## ARRANGEMENT OF REGULATIONS

## REGULATION

Citation.

1. These Regulations, which amend the Electricity Sector (Technical Standards) Regulations 2008 may be cited as the Electricity Sector (Technical Standards) (Amendment) Regulations 2010.

Amendment of Regulation 13 of the Principal Regulations. 2. Regulation 13 (3) (a) of the Principal Regulation is amended by deleting the words ", at the consumer's expense".

Amendment of Regulation 22 of the Principal Regulations.

- 3. Regulation 22 of the Principal Regulations is amended by substituting for it the following as regulations 22 -
  - "22. The provisions of this Subpart (B) shall apply to all new installations of meters, all replacements, substitutions or retrofitting of existing meter installations made in accordance with paragraph 14 (7) of the Public Electricity Supply Regulations (Third Schedule to the Act). In instances where the replacement, substitution or retrofitting of an existing meter installation is deemed necessary by a public supplier due to any unlawful act (regardless of whether the owner or occupier of the relevant premises has as yet been charged with or convicted of any such unlawful act with regard to such premises), the person to whom bills for the supply of electricity to the relevant premises are addressed by the public supplier shall be responsible for all costs associated with the replaced, substituted or retrofitted meter installation, the associated works, and the installation of the same."

Amendment of Regulation 64 of the Principal Regulations.

- 4. Regulation 64 of the Principal Regulations is amended by substituting for paragraph (a) the following as paragraph (a) -
  - "(a) in addition to the provisions of section 61 (2) (b), a public supplier shall be empowered to institute legal proceedings under sections 54 and 55 of the Act; paragraphs 27(2), (3) and (4) of the Third Schedule to the Act (the Public Electricity Supply Regulations); and paragraphs 50, 51, 56 and 60 of these Regulations, and"

Amendment of Regulation 65 of the Principal Regulations.

- 5. Regulations 65(a) of the Principal Regulations is amended as follows -
  - (a) by substituting for subparagraph (v) the following as subparagraph (v) "(v) is convicted of any violation of section 60 of the Act or paragraph 27(3) of the Third Schedule to the Act."
  - (b) by inserting immediately after paragraph (a) the following as paragraph (aa) -
    - (aa) to notify the public of the revocation, suspension or downgrading of the licence of any qualified person in accordance subparagraph (a)."
