REGULATIONS

Made Under

THE POST AND TELEGRAPH ACT

(Cap. 47:01):

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 97 OF THE POST AND TELEGRAPH ACT, THE FOLLOWING REGULATIONS ARE HEREBY MADE —

- 1. (1) These Regulations, which amend the Telephone Regulations, * may be cited as the Telephone (Amendment) Regulations 1977.
 - (2) Thèse Regulations shall come into operation on 1st January, 1978.
- 2. Paragraph (2) of Regulation 9 of the Principal Regulations is hereby amended by the substitution of the words "and re-connection fee of \$15.00" for the words "fee of 50 cents".
- Regulation 11 of the Principal Regulations is hereby amended by the insertion, immediately after the words "the annual rents", of the words "which shall be payable in advance".
- 4. Schedule A to the Principal Regulations is hereby amended in the following respects --
 - (a) by the substitution in paragraph 1(1) (i) of the words "\$80.00" for the words "\$45.00";
 - (b) by the substitution in paragraph 1(1) (ii) of the words "\$80.00 plus \$25.00" for the words "\$45.00 plus \$15.00";

- (c) by the substitution in paragraph 1(2) of the words "\$360.00"; "\$96.00"; "\$144.00"; "\$60.00" and "\$480.00" for the words "\$192.00"; "\$48.00"; "\$84.00" "\$36.00"; "\$240.00", respectively;
- (d) by the substitution in the proviso to paragraph 1(2) of the words. "\$50.00" for the words "\$30.00", wherever it appears:
- (e) by the substitution in paragraph 3 -
 - (i) of the words "service beyond an exchange area or for an external extension telephone" for the words "a direct exchange line, or for an external extension telephone, beyond an exchange area"; and
 - (ii) of the words "\$25.00" and "\$60.00" for the words "fifteen dollars" and "forty dollars" respectively, and
- (f) by the deletion of paragraph 6 and the re-numbering of paragraph 7 as paragraph 6.
- 5. Schedule B to the Principal Regulations is hereby amended in the following respects
 - (a) by the insertion in paragraph 1(b) immediately after the words "trunk call" of the words "or D.D.D. call";
 - (b) by the substitution in paragraph 2 for all the words, appearing before sub-paragraph (b) thereof, of the following words — "The charges for call units shall be as follows —
 - (a) A local call which registers one call unit shall each be charged at the rate of 12c.";
 - (b) by the substitution in paragraph 2(b) (i) of the words "24 cents", "36 cents", "48 cents" and "60 cents" for the words "16 cents", "24 cents", "32 cents" and "40 cents", respectively;
 - (c) by the substitution in paragraph 2(b) (ii) of the words "12 cents" for the words "8 cents", wherever they appear;
 - (d) by the substitution in the said paragraph 2(b) (ii) of the words "An additional fixed charge of 48 cents" for the words "A fixed charge of 24 cents";
 - (e) by the insertion immediately after sub-paragraph (ii) of paragraph 2 of the following sub-paragraph as sub-paragraph (iii) —

"When Local Call Timing is introduced the rates shall be as follows —

12 cents for every 3 minutes or part thereof between 7.00 a.m. — 5.00 p.m. 12 cents for every 6 minutes or part thereof

between 5.00 p.m. — 10.00 p.m. 12 cents unlimited time between 10.00 p.m. — 7.00 a.m.";

- (f) by the substitution in paragraph 3 of the words "15 cents" for the words "2 cents";
- (g) by the substitution in paragraph 4 of the words "24 cents" for the words "20 cents";
- (h) by the substitution in paragraph 5 of the words "60 cents" for the words "40 cents";
- (i) by the substitution in paragraph 6 of the words "48 cents" for the words "20 cents"; and
- (j) by the substitution in paragraphs 7 and 8 of the words "60 cents" for the words "20 cents" wherever it appears.
