#### DECLARATION

This is the Second Periodic Report to the National Assembly on the status of the work of the Parliamentary Sectoral Committee on Foreign Relations, pursuant to the requirement of paragraph 4 (ix) of Resolution 19 passed by the National Assembly on 15<sup>th</sup> May, 2003.

#### 1.0 INTRODUCTION

This second report of the Parliamentary Standing Committee on Foreign Relations (PSCFR) highlights its activities over the period 21<sup>st</sup> December, 2006 to 5<sup>th</sup> April, 2011 of the First Session of the Ninth Parliament. This report includes issues and concerns raised and discussed at meetings, as well as the Committee's interactions with Members of the Executive and other government functionaries.

### **1.1 BACKGROUND:**

#### The Parliamentary Sectoral Committee on Foreign Relations (PSCFR)

The PSCFR, one of four Parliamentary Sectoral Committees of the National Assembly, was established in 2003 by Resolution No. 19 of May 2003 of the National Assembly of the Eighth Parliament. Resolution No.19 gives effect to the Constitutional provision of Article 119B of the Constitution of Guyana. (Appendix I).

Standing Order 86 specifically provides for the establishment of this Committee and the other Sectoral Committees. These Committees have "responsibility for the scrutiny of all areas of Government policy and administration" as provided for in Standing Order 86.

#### 1.2. Nomination of Committee Members

The Committee of Selection in accordance with Paragraph 1 of Resolution 19 of 2003, and Standing Order 86 nominated seven persons to be Members of the PSCFR on 14<sup>th</sup> December 2006.

#### 1.3 Membership

During the period 21<sup>st</sup> December. 2006 to 5<sup>th</sup> April, 2011 of the First Session of the Ninth Parliament, the Membership of the Parliamentary Sectoral Committee on Foreign Relations consisted of seven (7) Members of which, four (4) are from the Government and three (3) from the combined Opposition in the National Assembly. In addition, there are two (2) Alternate Members, one (1) each from the government and the combined Opposition in keeping with the Standing Orders.

At its first Meeting held on 21<sup>st</sup> December 2006 the Committee elected Mr. Aubrey Norton and Mr. Bernard De Santos as Chairman and Vice Chairman, respectively.

#### Change in Membership

On 12<sup>th</sup> July 2007, the Committee of Selection at its 5<sup>th</sup> Meeting, on a proposal by Ms Gail Teixeira, M.P. and seconded by the Hon. Samuel A. A. Hinds, M.P., nominated Mr. Moses Nagamootoo, M.P. and Mrs. Pauline R. Sukhai, M.P as substantive and Alternate Members, respectively.

On 10<sup>th</sup> April, 2008, Mrs. Pauline Sukhai, M.P. was appointed Minister of Amerindian Affairs. This caused the Committee of Selection on the 3<sup>rd</sup> December, 2008 to appoint Mr. Moses Nagamootoo, M.P., as a substantive Member and Mr. Norman A. Whittaker, M.P. as the Alternate Member for the Government side of the Committee.

On 9<sup>th</sup> April, 2009, Mrs. Clarissa Riehl, M.P., the then Alternate Member, became a substantive Member, and Dr. George A. Norton, M.P. became the Alternate Member for the Opposition side of the Committee.

On 12<sup>th</sup> January, 2010, Mr. Bernard DeSantos, S.C., M.P. Chairman of the Parliamentary Sectoral Committee on Foreign Relations resigned. As a result, the Committee of Selection on 19<sup>th</sup> November, 2009, nominated Ms. Bibi S. Shadick, M.P. as a substantive Member. Ms. Shadick was elected as Vice-Chairperson of the Parliamentary Sectoral Committee on Foreign Relations on the 12<sup>th</sup> January, 2010.

On 24<sup>th</sup> March, 2010, Mr. Moses Nagamootoo, M.P. resigned from the Parliamentary Sectoral Committee on Foreign Relations, and on the 8<sup>th</sup> April, 2010, the Committee of Selection nominated Mr. Odinga N. Lumumba, M.P. as a substantive Member of the Committee.

On 21<sup>st</sup> October, 2010, Mr. Mohabir A. Nandalall, M.P., resigned from the Parliamentary Sectoral Committee on Foreign Relations. The Committee of Selection subsequently nominated Mr. Norman Whittaker, M.P. as a substantive Member and Mr. Mohamed F. Khan, M.P. as Alternate Member of the Committee.

#### ATTENDANCE

The attendance record for Members is attached at Appendix II.

#### 2.0 MANDATE

- 2.1 The mandate of the Parliamentary Sectoral Committee on Foreign Relations is outlined, generally, in paragraph 3 of Resolution 19 and refers specifically to the responsibilities of the Ministry of Foreign Trade and International Cooperation, the Ministry of Foreign Affairs and the Office of the President (Appendix III).
- 2.2 In order to discharge this mandate, the Committee has been empowered to scrutinize all areas of government activities as prescribed in the Revised Standing Orders No. 86. Its mandate also includes summoning Ministers and other Government officials to appear before the Committee and to give evidence whenever required. The Committee is also obligated to act on requests made by Parliament to address any urgent issue.

#### 2.3. Meetings

This Committee held twenty two (22) meetings during the period 21<sup>st</sup> December, 2006 and 5<sup>th</sup> April, 2011. The Committee Members agreed to meet twice a month at 3.30 p.m. on Thursdays for at least an hour. At the 11<sup>th</sup> Meeting of the Parliamentary Sectoral Committee on Foreign Relations held on

The Hon. Minister was accompanied by the following advisers:

After the introduction of the team the Hon. Minister presentation addressed the following:

- Background and purpose/objectives of the Strategic Plan of the Ministry of Foreign Affairs;
- The challenges facing the management of the Ministry of Foreign Affairs; and
- Weaknesses in the system and shortage of staff.

The Minister informed that the Ministry was *not* semi-autonomous, and as such it was subjected to the rules and regulations of the Public Service. He also stated that it was part of the Public Service and therefore was part of the Public Service Modernization process.

The Minister further stated that the fore runner to the Strategic Plan of the Ministry of Foreign Affairs Strategic Plan an Advisory Study that was undertaken with the assistance of the United Nation Department of Economic and Social Affairs team which advised on the orientation to the strategy.

The reorganization of the Ministry of Foreign Affairs thereafter had assistance from the CARICAD team and other distinguished experts who conducted a review of all findings. Thereafter the 2005 Strategic Plan was finalised.

The Minister stated that the various reviews and reform activities of the Ministry of Foreign Affairs facilitated an analysis of the workings of the Ministry and resulted in ideas of how the Ministry could improve its mission.

He further stated that there were benchmarks set and the diplomatic suite was tailored to its limited budget However, there were ways devised to make operations as manageable and effective as possible.

The Minister mentioned that some of the recommendations of the Strategic Plan were not accepted by the Government and as such the Minister was proceeding to implement those aspects that were accepted by the Government and were in consonance with the Public Service Reform process.

Despite some of these challenges mentioned and the shortage of the required skill personnel, the policies of the Ministry are shaped by the use of technical assistance from international agencies such as within the Commonwealth and other persons (Guyanese eminently qualified and of reputable background) from around the world who willingly make their service available to the Committee.

These persons aid heavily in the work of the Ministry as it deals with the multiple demands of the Ministry. The Minister also noted that there was the overlapping of responsibilities between the Ministry of Foreign Trade and International Cooperation and that outsourcing could not be avoided.

Details of the presentation are recorded in the verbatim records of proceedings.

#### (2) Presentation planned with Prof. Clive Thomas

Prof. Clive Thomas was expected to deliver a presentation on the "Economic Partnership Agreement". This decision was taken after the Committee agreed that there would be no great harm in listening to the views of the Professor before the Hon. Henry Jeffrey's presentation.

However, this presentation never occurred due to a lack of a quorum.

## (3) Presentation by Hon. Henry Jeffrey, Minister of Foreign Trade and International Cooperation

On Thursday 22nd May 2008 the Hon. Minister of Foreign Trade and International Cooperation at the request of the Committee appeared before it to discuss "The Economic Partnership Agreement (EPA)".

This presentation was done at a Joint Committee Meeting of the Foreign Relations and the Economic Services Committees held in the Chamber of the National Assembly.

The Hon. Minister made a power point presentation to the Committee with the following staff members as advisers:

The Hon. Minister stated how pleased he was to have the opportunity to engage Members of the two Committees as there were several relevant issues to be discussed. The Minister stated that on the 16<sup>th</sup> December 2007, the European Union and CARIFORUM established and Economic Partner ship Agreement.

He stated that his presentation would create an environment for discourse, as he had the experts there to assist with the questions on the presentation.

The presentation dealt with such areas as the background to the COTONOU Agreement. It examined the trade between the Europeans and the ACP countries, and noted the need for development to be an integral part of the Agreement.

The Hon. Minister did not want to look at the totality as CARIFORUM was part of the EU trade and in terms of market share there was not even one percent of import of it or export.

He spoke of the expectations of the LOME Agreement and Globalisation to the extent that the formulae the developed countries have to deal with the WTO, the small and vulnerable economies did not have, but there was recognition within the context of flexibility within reciprocity.

Other areas are: (i) The EPA and the New World; (ii) CARIFORUM- EC Negotiations; and (iii) Government Procurement

Details of the presentation are recorded in the verbatim records of this date.

### (4) Presentation by Hon. Carolyn Rodrigues- Birkett, Minister of Foreign Affairs

On Thursday 1<sup>st</sup> June, 2010 the Hon. Carolyn Rodrigues-Birkett, Minister of Foreign Affairs, appeared before the Committee, to discuss: "The Issues of Latin American Affairs in general, with specific emphasis on our border policy and to update the Committee on the Ministry's Strategic Plan".

The Hon. Minister made a power point presentation before the Committee with the following staff members as advisers:

The Minister in her presentation addressed the following issues:

- The Border Issues with Venezuela and Suriname;
- Overview of Developments in Latin America;
- The creation of the Union of South American Nations (UNASUR); the Community of Latin American and Caribbean States (CALC); and the Bolivian Alternative for the Americas (ALBA)
- The Bodies of UNASUR and Sector Bodies.;
- The Recent Development with UNASUR;
- The Analysis/ Benefits of the UNASUR.

In conclusion, the Minister detailed the Ministry's Strategic Plan: input of staff from the headquarters and the missions. The objectives of the plan with relations to human resources, promotion, training and development, posting and pay were also detailed.

Details of the presentation are recorded in the verbatim records of this date.


#### 4.0 CONCLUSION

#### **EIGHT PARLIAMENT OF GUYANA**

#### SECOND SESSION (2002-2003)

#### NATIONAL ASSEMBLY

#### **RESOLUTION NO. 19**

WHEREAS Article 119 B of the Constitution provides:

There shall be parliamentary sectoral committees established by the National Assembly with responsibility for the scrutiny of all areas of Government policy and administration including (I) natural resources (ii) economic services (iii) foreign relations and (iv) social services

#### RESOLVED,

1. The Sectoral Committees shall consist of seven (7) members, four (4) representing the Government and three (3) representing the Opposition. The Government and Opposition are entitled to elect one alternate member each for each Sectoral Committee.

2. The Chairperson and Deputy Chairperson of each sectoral committee shall be elected from opposite sides of the National Assembly and would alternate annually with two (2) Sectoral Committees each to be chaired by the Government and Opposition respectively.

3. The committees shall, in the discharge of their scrutinising role, examine all policies and administration, for each sector, to determine whether the execution of government policy is in consonance with the principles of good governance and in the best interest of all the people of Guyana.

4. The committees shall have the authority to:

Determine areas of government activity for scrutiny or specific examination;

- Request the Minister assigned responsibility for the sector to submit
  written or oral information, including government documents and
  records about any specific area of government policy and
  administration;
- iii Review existing legislation on government policy and administration for any of the sectors;

- v Summon persons to give evidence, scrutinise government documents, papers and records;
- Visit any government activity or project in Guyana as agreed and arranged by the Committee;
- vi In the discharge of their mandate, utilise the services of experts, specialists and other sources of advice as they determine;
- vii Establish a timeable for the conduct of their work;
- win Make recommendations to the National Assembly on legislation or any other action to be taken on matters falling within their purview;
  - ix Submit periodic reports to the National Assembly on their work; and

Invite comments, from the Minister assigned responsibility for the sector on their recommendations or reports.

5. The National Assembly, notwithstanding the current work programme of any sectoral committee, may request the committee to give prompt attention to a particular aspect of the policy or administration of the government for a sector 6. The provisions of Standing Order No. 70A shall apply to the Sectoral Committees

#### AND FURTHER RESOLVED,

7. The Gazetted ministerial responsiblilities shall be allocated to each Sectoral Committee in the manner set out in Schedule 1.
