ORDINANCE No. 13 of 1950.

An Ordinance to amend the Georgetown Public Free Library A.D. 1950. Ordinance, in order to provide for the establishment of branch public libraries and other public library services at any place in the Colony and for purposes connected therewith.

Be it enacted by the Governor of British Guiana, with the advice and consent of the Legislative Council thereof, as follows:—

- 1. This Ordinance may be cited as the Public Free Library Short title. Ordinance, 1950, and shall be construed with the Georgetown Chapter 89. Public Free Library Ordinance, hereinafter referred to as the Principal Ordinance.
- 2. The definition of the expressions "the library" and "the Amendlibrary buildings" in section two of the Principal Ordinance is ment of hereby repealed and the following definition substituted therefor— section 2 of the library" and "the library buildings" mean respectively the public library and branch public libraries Ordinance.

Section three of the Principal Ordinance is hereby amended —

(a) by re-numbering the section as subsection (1);

(b) by the substitution for the expression "Georgetown Public Free Library" in subsection (1) of the expression "Public Free Library"; and

(c) by the addition of the following subsection — (2) Branch public libraries and other public library services may be established as hereinafter

provided at any place in the Colony."

4. Section four of the Principal Ordinance is hereby amended by the deletion of the full stop at the end thereof and by the addition thereto of the words "and from such other moneys as may be contributed by corporate bodies and local authorities."

- 5. The Committee established by section five of the Principal Ordinance by the name of "The Committee of the Georgetown Public Free Library" shall hereafter be known as "The Committee of The Public Free Library".
- Section six of the Principal Ordinance is hereby amended —
 - (a) by the insertion after the word "may" in the second line of the words "establish from time to time such branch public libraries and other public library services as may be considered desirable and practicable and may"; and

(b) by the substitution of the word "buildings" for the word "building" in the eighth line.

7. Paragraph (b) of section ten of the Principal Ordinance is hereby amended —

(a) by the substitution for the words "library building" of the words "Public Free Library building"; and

(b) by the deletion of the full stop at the end thereof, and the addition thereto of the following -"or for such other purposes as the Committee may consider desirable."

8. The Principal Ordinance shall hereafter be cited as the Ordinance Public Free Library Ordinance.
