ORDINANCE No. 50 OF 1950.

AN ORDINANCE to incorporate the Christian Catholic Church. [30th December, 1950.

BE IT ENACTED by the Governor of British Guiana, with A.D. 1950 the advice and consent of the Legislative Council thereof, as follows: -

Short title. This Ordinance may be cited as the Christian Catholic Church (Incorporation) Ordinance, 1950.

2. The Reverend Edgar Stanley Jeffrey, the Superintendent tion of the in British Guiana of the Christian Catholic Church and his successors in that office shall be a body corporate under the name of the Christian Catholic Church in British Guiana and by that name shall have perpetual succession and have the full power to purchase, take, hold, enjoy, transport, mortgage, lease, invest and otherwise deal with and dispose of all property movable and immovable of what nature or kind soever, hereby vested and hereafter acquired and may sue and be sued in all Courts of Justice and before all magistrates in the Colony.

All movable or immovable property in the Colony which, Vesting of at the commencement of this Ordinance is held by or vested in property.

the name of the said Edgar Stanley Jeffrey (of which immovable property a description is set forth in the Schedule hereto) Schedule. shall be held by, and is hereby vested in, the body corporate aforesaid.

4. All property movable or immovable of what nature or Vesting kind soever hereafter bequeathed by will or otherwise given of property beto the Christian Catholic Church in the Colony, shall be deemed queathed. to be the property of the said body corporate.

- 5. All property vested in, or hereafter acquired by the said Tenure of body corporate shall be held by the said body corporate for the property. use and benefit of the Christian Catholic Church in British Juiana.
- 6. All process which is required to be served on the Service of If ristian Catholic Church shall be deemed to be sufficiently Process. reduced
 - (a) if a copy thereof is left with the Superintendent at any place within the Colony, or with an adult inmate at the place of residence in the Colony of the Superintendent; or

(b) if a copy thereof is published in the Gazette.

7. Nothing in this Ordinance shall be deemed to affect any Saving right of His Majesty the King, His Heirs and Successors or of the rights any body politic or corporate or of any other person or persons of His except such as are mentioned in this Ordinance, and claiming and others. by, from, through or under them.

SCHEDULE.

Section 3.

1. "North half of lot 53 (fifty-three) and north half of lot 56 (fifty-"six), Anna Catherina, situate on the west sea coast of the county "of Demerara and Colony of British Guiana, as laid down and defined "on a plan by John Peter Prass, Sworn Land Surveyor, dated 17th "day of March, 1880, and deposited in the Registrar's Office on the "12th day of March, 1885, no buildings thereon".

2. "Sub-lots a and b of lot number 40 (forty), south of the public "road, Rose Hall in the Rose Hall Village District, in the county "of Berbice, as shown on a plan by E. C. H. Klautky, Sworn Land "Surveyor, dated September, 1911, and deposited in the Office of "the Registrar at New Amsterdam, Berbice, on the 10th July, 1912,

"no building thereon".

3. "A lease of the piece or parcel of Crown land situate in the Village "of Bartica at the confluence of the Essequibo and Mazaruni rivers "in the County of Essequibo and Colony aforesaid and more fully "described as follows the tract commences at a paal (J.P.) marking "the South-western corner of Lot 97, Third Avenue Bartica, the "said Lot originally laid out and shown on a plan dated August, "1887 by Wm. Chalmers, Assistant Crown Surveyor, and extends "in facade N 16° 15' (Tr) 61.78 feet with a depth N 106° 15' (Tr) "of 185.34 feet, being Lot No. 97, Third Avenue, Bartica Village, 'containing .263 acres as shown on a diagram dated the 8th day "of March, Nineteen Hundred and Forty by Jos. Phang, Government "Surveyor".

4. "A lease of the piece or parcel of Crown land situate at and being "Lot 34, East side Bartica-Potaro Road, in the County of Essequibo "and Colony aforesaid, containing 5.469 acres as shown on a plan "by J. A. Sweetnam, Asst. Government Surveyor, dated the 11th

"day of December, Nineteen Hundred and Forty-Three".
