ORDINANCE No. 7 of 1953.

An Ordinance to amend the Law Revision Ordinance, 1949.

[2nd May, 1953.]

BE IT ENACTED by the Governor of British Guiana, with the advice and consent of the Legislative Council thereof, as follows:—

A.D. 1953

- 1. This Ordinance may be cited as the Law Revision (Amendment) Ordinance, 1953, and shall be construed and read as one with the Law Revision Ordinance, 1949, hereinafter referred to as the Principal Ordinance.
- 2. Subsection (2) of section three of the Principal Ordinance is hereby amended by the repeal of the proviso thereto.
