ORDINANCE No. 47 OF 1954

An Ordinance to amend the Motor Vehicles and Road Traffic (Amendment No. 2) Ordinance, 1950, with respect to the licence fees for certain vehicles.

[25th December, 1954]

ENACTED by the Legislature of British Guiana: -

1. This Ordinance may be cited as the Motor Vehicles and Road Traffic (Amendment) Ordinance, 1954, and shall be construed and read as one with the Motor Vehicles and Road Traffic (Amendment No. 2) Ordinance, 1950, hereinafter referred to as the Principal Ordinance.

2. As from the 1st January, 1955, there shall be charged, levied and paid in respect of the vehicles and in respect of the matters specified in paragraphs 1, 2 and 3 of the Schedule to this Ordinance the fees therein prescribed in substitution for the fees prescribed in paragraphs 1, 3 and 4 respectively in PART A of the Schedule to the Principal Ordinance.
