# REPORT OF THE SPECIAL SELECT COMMITTEE OF THE NATIONAL ASSEMBLY ON THE MEDICAL PRACTITIONERS (AMENDMENT) BILL 2001

#### The Medical Practitioners (Amendment) Bill 2001

The Medical Practitioners (Amendment) Bill 2001 – Bill No. 13 of 2001 – seeks to amend the Medical Practitioners Act 1991 (No. 16 of 1991) to provide for changes in the composition of and in the procedure for the election of Members of the Medical Council of Guyana.

#### Publication, Introduction and First Reading

2. The Bill was published in the Gazette and was introduced in the National Assembly and read the first time on 15<sup>th</sup> November, 2001.

#### Second Reading

3. At the sitting of the National Assembly on 29<sup>th</sup> November, 2001, the Minister of Health, the Hon. Dr. Leslie S. Ramsammy, M.P., moved and spoke on the motion for the second reading of the Bill. The Leader of the Opposition, Mr. H. Desmond Hoyte, S.C., M.P., spoke to the motion. After the Minister had replied, the motion was put and carried and the Bill was read a second time.

#### Committal to Select Committee

4. On a motion moved by the Minister of Parliamentary Affairs, the Hon. Reepu Daman Persaud, O.R., J.P., M.P., immediately after the Bill was read a second time on 29<sup>th</sup> November, 2001, the Assembly committed the Bill for consideration by a Special Select Committee.

#### Amendments made by the Special Select Committee of the National Assembly

Clause 2 the proviso to the inserted paragraph

- (a) Insert before the word "election" the word "first".
- (b) Insert after the word "Minister" where that word occurs for the first time the words "within thirty days of the coming into operation of this paragraph".

Clause 3 the inserted section 26 subsection 2

Delete the words "however constituted".

Clause 4 the substituted subparagraph (d)

Delete the words "with the approval of the President".

Clause 5

Insert immediately after clause 4-

"Registration deemed valid.

- 5. Notwithstanding anything in this Act –
- (a) a medical practitioner registered with higher or additional qualification or training under section 7;
- (b) a person registered as a medical practitioner under section 6;
- (c) a person registered in the Annual Register of Medical Practitioners pursuant to section 8;
- (d) a person registered with internship, institutional or full registration or with a licence under section 10,

between the period commencing on 20<sup>th</sup> December, 1999 and ending on the date when the Council is constituted and the members thereof enter upon the duties of their office shall be deemed to be duly, validly and lawfully registered in full compliance with every provision of this Act relating to such registration.".
