A BILL

Intituled

AN ACT to incorporate the Board of Trustees of the Wesleyan Church of Guyana to hold the property in Guyana of the Pilgrim Holiness Church and for purposes connected therewith.

WHEREAS the Wesleyan Church is a Church formed on the 10th day of October, 1968 to carry on the work formerly carried on by the Wesleyan Methodist Church of America and the Pilgrim Holiness Church throughout the world;

AND WHEREAS movable and immovable property in Guyana have, from time to time, been acquired for use by, or in connection with the work of, the said Pilgrim Holiness Church;

AND WHEREAS the said Pilgrim Holiness Church is desirous that all the said property may lawfully be used by the said Wesleyan Church to the intent that the work of the said Pilgrim Holiness Church may be carried on without interruption, that a Board of Trustees be incorporated to hold the said property and all movable and immovable property of the Wesleyan Church in Guyana and that such provisions be made in relation to the property connected with the said Wesleyan Church as are hereinafter contained:

1. This Act may be cited as the Wesleyan Church in Guyana (Incorporation) Act 1975.

- 7. All property vested in, or hereafter acquired by, the property. Board shall be held by the Board in trust for the use and benefit of the Church subject, however, to the regulations of the Church as are, from time to time, promulgated by the District Board of Administration and shall not be sold, leased, mortgage, charged, or otherwise dealt with or disposed of without the prior approval in writing of the District Board of Administration.
- 8.(1) The Board, may, with the approval of the District Power to Board of Administration, make such rules and regulations for and reguconducting and regulating its affairs and for the carrying out of lations. its duties as it thinks fit.
- (2) Subject to subsection (1), the Board shall have power to regulate its own proceedings.
- 9.(1) Any document requiring to be formally executed by Execution or on behalf of the Board shall be deemed sufficiently executed documents if signed by the President or the Chairman or a member and the Secretary, of the Board.
- (2) Any other document not required by law to be executed under seal shall be deemed to be duly executed if signed by a person or persons authorised by the Board so to sign and such person shall be deemed to be the person designated in such document and to be so authorised, unless the contrary is proved

Every person signing as President, Chairman, member, or secretary of the District Board of Administration or the Board shall be taken so to be until the contrary is proved and any statement or certificate that any person named therein is the President, Chairman, member or Secretary of the District Board of Administration or the Board or that a document is a true copy of any document or of an extract from any document or entry in the books or records of the District Board of Administration or the Board purporting to be signed by the President or by the Chairman or by a member and the Secretary of the District Board of Administration or the Board shall be admissible as prima facie evidence of the fact or of the original entry.
