- 1. (1) This Act may be cited as the Miscellaneous Enactments short title (Amendment) Act, 1967, and so far as it amends any Ordinance shall and combe construed and read as one with that Ordinance and all amendments thereto.
- (2) This Act shall be deemed to have come into operation in respect of item 3 of the schedule hereto at the commencement of the -Official Designations Ordinance.
 - 2. The enactments specified in the first column of the schedule Amendment to this Act shall be amended to the extent set out in the second column of enactments. thereof.

EXPLANATORY MEMORANDUM

The object of this Bill is to effect divers amendments to a miscellany of enactments.

2. In keeping with the Public Holidays Ordinance as amended by the Public Holidays (Amendment) Act, 1967, items 1, 2, 12 and 13 of the schedule to this Bill seek to amend the provisions of the High Court Ordinance, Chapter 7, the Factories Ordinance, Chapter 115, and the Bakeries (Hours of Work) Ordinance, Chapter 120, which enumerate the days to be observed as holidays by the High Court and the registry of the Supreme Court under the High Court Ordinance and for the purpose of the payment of special wage rates under the Factories and Bakeries (Hours of Work) Ordinances. Thus, for that purpose, Eid-Ul-Azha, Phagwah and Labour Day will be substituted for Boxing Day, New Year and Whitsun; and the Queen's birthday, Easter Eve, the day after Easter Monday, Ascension Day and Whit Monday and Tuesday will cease to be specified by the High Court Ordinance as court or registry holidays.

- 3. Item 3 of the schedule seeks to amend the Official Designations Ordinance, Chapter 57, retrospectively to regularise the effect of orders changing official designations and dispense with the necessity for publication in the Gazette of a separate notice specifying the effective date of any order of that kind, as presently required by the Ordinance.
- 4. The amendments mentioned in items 4 to 7 (inclusive) 10, 11, 14 and 15 of the schedule are consequential to the provision by way of Supplementary Estimates in 1966 for the new office of Assistant Chief Labour Officer and seek to make statutory provision for that officer's functions, which are in keeping with his designation.
- 5. Items 8 and 9 of the schedule seek to implement the terms of International Labour Organisation Convention No. 87 by reodering a decision of the Registrar of Trade Unions to withdraw or cancel a union's certificate under the Trades Unions Ordinance, Chapter 113, subject to appeal to the High Court.
