A BILL

Intituled

An Act to amend the Rice Marketing Ordinance, to dissolve the 1yana Rice Development Company, Limited, and to make m or amendments to the Guyana Rice Producers Association Ordina ce.

Enacted by the Parliament of Guyana:—

Short title and commencement.

- 1. (1) This Act may be cited as the Rice Marketing (Am dment) Act, 1969, and shall be construed and read as one with the ce Marketing Ordinance, hereinafter referred to as the Principal O dinance, and all amendments theresto.
- (2) This Act shall come into operation on such day (her inafter referred to as "the appointed day") as the Minister responsible for finance may, by order, appoint.
- Amendment of section 2 of Chapter 249. Section 2 of the Principal Ordinance is hereby amen ed by the addition of the following definition immediately after the de nition of the expression "the Association"-

[&]quot; "the Corporation" means the Guyana Rice Corpora on established by the Guyana Rice Corporation Or ler, 1969;".

- Section 4 of the Principal Ordinance is hereby amended Amendment of section 4 of Chapter 249. in the following respects
 - (a) by the repeal of subsection (1) and the substitution therefor of the following subsection -
 - "(1) The Board shall consist of eleven persons who shall be appointed by the Minister as follows-
 - (a) two public officers;
 - (b) one person representing the interests of consumers of rice; and
 - (c) eight other persons appearing to the Minister to be qualified as having had experience in matters relating to the production, manufacture or marketing of rice or to agriculture, industry or commerce generally.
 - (b) by the repeal of subsection (2);
 - (c) by renumbering subsections (3) to (11) as subsections (2) to (10), respectively; and
 - (d) by the substitution of "subsection (1)" for "subsections (1) and (2)" appearing in the renumbered subsections (5) and (9).

- (2) The assets of the company (including rights and interests) shall be transferred to and vested in the Guyana Rice Corporation (hereinafter refered to as "the Corporation") on the appointed day.
- (3) Liabilities incurred by the company prior to, and subsisting immediately before, the appointed day shall, be discharged by, and be enforceable against, the Corporation as if the said liabilities had been incurred by the Corporation.
- (4) Nothing in subsection (2) or (3) of this section shall apply to rights or liabilities under any contract of service.
- (5) All deeds, bonds, instruments or other documents which were subsisting immediately before the appointed day and affected the company, shall in so far as they relate to the undertaking of the company, be of as full force and effect against or in favour of the Corporation, and enforceable as fully and effectually as if, instead of

the company, the Corporation had been named therein or had been a party thereto and where immovable property has, by virtue of this section, vested in the Corporation the Registrar of Deeds shall take due notice thereof and shall make such annotations on the records as may be necessary.

- (6) All proceedings commenced prior to the appointed day for the enforcement of any rights or liabilities which are transferred or attached to the Corporation by virtue of this section may be continued by or against the Corporation, and any such proceeding may be amended accordingly.
- (7) The Corporation may, as from the appointed day, continue to employ, on such terms and conditions as may be agreed on between the Corporation and him, any person employed with the company immediately before the appointed day, and in respect of any person so employed the Corporation shall be the successor of the company with regard to leave or superannuation rights or benefits whether accrued, earned, inchoate or contingent.
- (8) To such extent, if any, as may be required by the provisions of article 8 of the Constitution, provision is hereby made in terms of subparagraphs (a) and (b) of paragraph (1) of that article in relation to any property, including any interest in or right over such property, acquired by the Corporation under this section.
 - (9) Section 22 of the Principal Ordinance is hereby repealed.

"(7) The Council shall keep such books and acounts as may be necessary to record its receipts and payments and shall, on or before the 31st March in each year, cause its books and accounts in so far as they relate to its transactions to the 31st December in the preceding year to be audited by an auditor qualified under subsection (8) of section 109 of the Companies Ordinance and published in at least one newspaper.".

EXPLANATORY MEMORANDUM

In order to implement the Government's policy to expand and modernise the rice industry, a public corporation (the Guyana Rice Corporation) has been established under the Public Corporation Ordinance, 1962 for the purpose. It is proposed that the Corporation should replace the Guyana Rice Development Company Ltd. This Bill therefor includes provision for the dissolution of the company and for the transfer of its assets and liabilities to the Corporation. It is intended that the Guyana Rice Marketing Board will continue to export rice to the traditional markets in the Caribbean and that the Corporation will endeavour to develop an export trade with other markets. In order to enable the Corporation to carry out its functions it is necessary to amend the Rice Marketing Ordinance (Chapter 249) so that the Board will no longer lenjoy the monopoly over the disposal of padi, rice and their by-products. Provision is made in clause 3 of the Bill for the reorganisation of the Guyana Rice Marketing Board. Clause 9 seeks to make provision enabling the Minister to give directions to the Board.

INSTRUMENT APPOINTING MEMBERS OF THE GUYANA RICE CORPORATION

WHEREAS by the Guyana Rice Corporation Order, 1969, made under the Public Corporation Ordinance, 1962, provision is made for the establishment of a public corporation to be known as the GUYANA RICE CORPORATION with effect from 28th August, 1969.

AND WHEREAS it is provided by subsection (2) of section 3 of the said Ordinance that a Corporation shall consist of one official member and of such number of other members as the Cabinet may from time to time determine;

AND WHEREAS it is provided by subsection (3) of the said Ordinance that a chairman and deputy chairman of a corporation shall be appointed by a Minister from among the members of the Corporation;

AND WHEREAS it is provided by subsection (5) of section 3 of the said Ordinance that a member of the Corporation may be appointed for any period not exceeding three years but shall be liable to be removed from office at the pleasure of the Cabinet:

NOW, THEREFORE, in pursuance of the said provisions and in accordance with the decision of the Cabinet that the GUYANA RICE CORPORATION shall consist of eleven (11) members (including the official member) to be appointed by the Minister responsible for Finance, I do hereby appoint the following persons as members of the Corporation for a period of one (1) year with effect from the 28th August, 1969:
