EXPLANATORY MEMORANDUM

This Bill seeks to give effect to certain proposals in the budget for this year.

Clause 2 seeks to amend the First Schedule to the Income Tax (In Aid of Industry) Act,

Cap. 81.02, to give tax relief to manufacturers of certain items included therein.

Clauses 3 and 4 seek to amend section 14 (2) and the First Schedule to the Property Tax Act,

Cap. 81:21, to grant further relief to any individual, a body of persons or a company from property

tax.
