ORDER

MADE UNDER

THE CUSTOMS ORDINANCE

(Chapter 309)

UNDER SECTION 8 OF THE CUSTOMS ORDINANCE AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE MINISTER RESPONSIBLE FOR FINANCE AS FOLLOWS:—

1. This Order may be cited as the Customs Duties (Amendment) (No. 2) Order, 1969.

2. Part I of the First Schedule to the Customs Ordinance is hereby amended —

- (a) by the substitution for the rates of import duty set out therein against the item numbers and commodities relating thereto mentioned in the first and second columns of the first schedule to this Order, of the rates of import duty set out in the third column of the first schedule to this Order against the said item numbers and commodities, respectively;
- (b) by the deletion of item numbers 899-08.01 and 899-08.02 and the commodities and rates of import duty relating thereto and the substitution therefor of the item numbers, commodities and rates of import duty mentioned in the second schedule to this Order,

there being chargeable accordingly additional duty calculated in the manner prescribed by paragraph 3 of the Customs Duties (Amendment and Imposition) Order, 1967*, on imported goods classified under any such item number and referred to in that paragraph as in force for the time being.

3. The third schedule to the Customs Duties (Amendment and Imposition) Order, 1967*, is hereby amended by the substitution for

- (a) item number 899-08.01, of item numbers 899-08.011 and 899-08.012; and
- (b) item number 899-08.02, of item numbers 899-08.021 and 899-08.022.
