## BRITISH GUIANA

RULES MADE UNDER SECTIONS 75 AND 77 OF THE SUPREME COURT ORDINANCE, CHAPTER 7.

- WE, WILLIAM ADRIAN DATE, Chief Justice, (Acting), KEITH LYNDELL GORDON, HAROLD BRODIE SMITH BOLLERS, HENRY AUBREY FRASER, Puisne Judges of the Supreme Court of British Guiana, with the advice and assistance of SIDNEY LYONS VAN BATENBURG-STAFFORD, Queen's Counsel, and Hl:JGH CECIL BENJAMIN HUMPHRYS, Solicitor, being majority of the Rule-Making Authority under the powers conferred by the Supreme Court Ordinance and all powers and authorities thereunto enabling do hereby make the following Orders and Rules:-
- 1. These Rules inay be cited as the Supreme Court (Amendment) Rules; 1961, and shall be construed and read as one with the Supreme Court Rules, 1955, hereinafter referred to as the Principal Rules and any rules amendini the same.
- 2. The Principal Rules are hereby amended by the substitution for rule 2 of Order 36 of the following-rule:-

"Parate Execution.

- 2. (1) In any case where any sum is authorised by law to be recovered by parate execution the summation shall be served by the marshal or such other person as may be appointed by the Registrar either generally or in any specific case to serve summations, personally upon the debtor or the proprietor of the property upon which the execution is sought. If such person or proprietor is dead or cannot be found or such proprietor is not known the marshal or other person appointed to serve the summation shall file a certificate to that effect in the Registry and thereafter service shall be effected by affixing the summation to the main door of the principal building on the property or 'if there be no building to some conspicuous object on the property. The like writs may thereafter be issued in the case of any sum so authorised to be recovered as may be issued under the rules of this Order, in the case of any sum direct d to be paid by any judgment or order.
- (2) Subject to the provisions of these rules the practice and procedure relating to parate execution shall continue in force."
