CHAIRPERSON'S REMARKS

The year 2014, though subject to a regime of challenges, mainly pertaining to difficulties accessing the Commission's Budget, has been one that has been productive.

During this year, the Commission conducted three legs of engagement at the New Opportunity Corps, wherein, there was a significant infusion of ideas salutary to the rights and interests of Guyana's children in contact with the law. It has been an engagement that constituted a significant capacity building of the New Opportunity Corps- Guyana's only juvenile correctional facility. As a significant corollary, the Commission has also engaged the children, resident at the Corps, with a leadership and empowerment programme intended to educate and empower, so that such children, can be reintegrated into their communities as productive citizens.

During 2014, also, the Commission also engaged such centres as the Kuru Kuru, Sophia and Vryman Erving training centres with a similar engagement of staff and students. This engagement has been guided by the thrust of youth education and empowerment.

In 2014, an innovative initiative was started i.e. the RCC's Child Rights and Poetry workshop intended to convey the spirit and intent of the RCC's principal human rights instrument: the CRC, through the medium of poetry. This initiative was premised on the pedagogic principles that children learn in a myriad of ways.

The Child Participation Action Plan workshop was a definitive endeavor intended to make manifest the spirit and intent of Article 12, of the CRC i.e. to empower children with the capacity and facility to effectively participate in the respective settings in which they exist.

The Commission's engagement of the Ptolemy Reid Rehab Centre constituted a thrust to cultivate and engender a societal ethos benevolent to Guyana's children with disabilities. It makes manifest an endeavor to actualize the spirit and intent of the UNCRPD.

The success of 2014 will inspire and activate renewed vigour in the interest of Guyana's children. I implore all stakeholders to come on board a movement for our children.

INTRODUCTION





Composition of 2014 Action

Plan

During the first quarter of 2014, the CEO composed a 2014 Action Plan which was ratified at a special meeting of the Commissioners. The Action Plan was composed utilizing the carious mandates as adumbrated by the RCC's Strategic Plan. These mandates include:

- · Promoting of Child Rights
- Promoting the Rights if Children
 including of policy levels and in Government decisions
- Monitoring compliance making recommendation for the compliance with international instruments.
- Establishing of Complaint Mechanism with tracking system.
- Fundraising, Operational and Capital.

First leg of engagement with the New Opportunity Corps.

During the first quarter of 2014, the RCC conducted a capacity building training with the staffers of the New Opportunity Corps. The training focused on the need of the child, the UNCRC, the models of human development and the importance of evidence based decision making.

The capacity building session was aimed at empowering the staff of the coops with a knowledge and appreciation of the critical nature of their respective roles in the psychosocial rehabilitation of the children under their care.

The session would mark an important juncture in the cultivation of a productive relationship with the Ministry of culture, Youth and Sports. A relationship that would see the Commission doing pioneering empowerment work at the NOC, KKTC, Sophia Training Centre and Vryman Erving Training Centre.

Capacity Building Workshop with the staffers of the Sophia Training Centre and Kuru Kuru Training Centre.

During the first quarter of 2014, the RCC conducted similar workshops with the staffers at the Sophia Training Centre and the Kuru Kuru training centre.

Both of these centres are vocational skills training institutions with a clientele of children and youth. This clientele would be significantly comprised of those children and youth who would have dropped out of or underperformed in the regular school system.

Promoting Child Rights through Poetry

During the first quarter of 2014, the RCC conducted a **Child Rights through Poetry** workshop. This workshop was attended by ten Georgetown schools. The workshop was facilitated by the CEO Mr. Amar Panday and Mr. Yaphet Jackman.

The workshop examined the basics of poetry, Guyanese poetry and appreciating child rights through poetry.

Second leg of the NOC engagement.

During the second quarter of 2014, the RCC conducted the second leg of the engagement with the New Opportunity Corps. This engagement took the form of a two day workshop with both the staff and students of the corps. The session with the staff focused on the respective legislation which apply to the corps, as well as the strengthening of the psycho social role and capacity of the staff. The session with the students focused on personal and leadership development as well as literacy development.

The engagement with the NOC represents a key focus of the Commission. It is a focus that is committed to the protection, empowerment and education of Guyana's at risk and disadvantaged children.

Exercising the Mediator Role of the Commission

During the year 2014, the RCC sought to exercise its constitutionally mandated role as a mediator pursuant to the objective of the protection of Guyana's children. As a result, a number of cases on the investigative desk of the Commission were mediated. This led to an amelioration and betterment, both on a short term and permanent basis, of the plight of a number of children in atrisk and vulnerable positions.

Capacity Building with the senior staffers of the NOC, Kuru Kuru, Sophia and Vryman's Erven's training Centres.

In the second quarter of 2014, the RCC conducted a special training with the senior staffers of the NOC, Kuru Kuru, Sophia and Vryman's Erven's training Centres. This workshop focused on Professionalism and Leadership as well as an in depth examination of the Sexual Offences Act of 2010. This workshop was conducted by the Deputy Chairperson Mrs. Rosemary Benjamin Noble and other commissioners, together with CEO of the RCC, Mr. Amar Panday.

The decision to focus on the Sexual Offences Act was premised on allegations of sexual abuse at the NOC. It was reasoned that briefing senior staffers on the comprehensive nature of the Act would provide the requisite knowledge that would allow them to play meaningful roles in combating this malady.

Consultation with the Strategic Management Plan of the Guyana Police Force

In the second quarter of 2014, the chairperson, deputy chairperson and CEO meet with the GPF's Strategic Management Team.

The consultation focused on a number of policy areas with the Commission submitting its policy positions in a number of areas of child protection and empowerment which converge with the role and mandate of the Guyana Police Force. Issues related to strategy on youth gangs, youth crime, and juvenile and child justice including wandering, criminalization and diversion; standard operating procedures for the police to deal with violence near schools and police intervention; drug use among children and strategies to keep it out of school (peer groups, counseling, and welfare programmes), were all discussed.

The Team committed to incorporating the policy positions of the RCC into the Strategic Management Plan of the Force. Both parties also committed to working closer to ensure the protection of Guyana's children.

Second Leg of the engagement with the Kuru Kuru Training Centre

During the third quarter of 2014, the RCC conducted its second engagement with the Kuru Kuru training Centre. This workshop entailed working with both the staff and students of the Centre in the areas of the UNCRC and the CEDAW and the ways in which they intersect.

A session was also conducted with the staff of the corps on professionalism, leadership and team building. Both the Staff corps and student body of the Centre hail from predominantly rural and hinterland regions. Thus, it is contemplated that the work done with the Centre, will also benefit those rural and hinterland communities.

As the principal body responsible for the dissemination of the articles of the UNCRC, the RCC is committed to sharing the articles of the UNCRC throughout the rural and hinterland communities of Guyana.

Engagement with the Ptolemy Reid Rehabilitation Centre

During the third quarter of 2014, the RCC conducted its first engagement with the senior staffers of the Ptolemy Reid Rehabilitation Centre.

This workshop focused on the Needs of the child, the UNCRC and the RCC's Investigative Mechanism. The engagement with the Rehab Centre reflects the commitment of the Commission to address the protection, empowerment and education needs of Guyana's differently abled children. It is anticipated that the training provided to the staff will enhance their capacity to better care for the children under their superintendence.

The Commission, through this initiative, has sought to forge a closer relationship with this Centre.

Community Outreach and Partnerships

Throughout the year 2014, the RCC has sought

to establish strong working relationships with communities spanning the administrative regions of Guyana. Communities which were targeted include Bush lot, Meten Meer Zorg, Kitty and Buxton encompassing administrative regions 2, 3 and 4.

During the year, workshops were conducted with youth activists from these communities who, in turn, would lead the way in the protection, empowerment and education of the children in their communities.

The training provided to these youth activists include the UNCRC, CEDAW, Literacy and Leadership Development. The Commission continues to maintain a relationship with these communities working closely with our trained ambassadors in cultivating a community ethos conducive to upholding the rights of the child.

Third Leg of the NOC engagement

During the third quarter of 2014, the RCC conducted the third leg of its engagement with the NOC. This leg was conducted jointly with the Guyana Responsible Parenthood Association (GRPA).

The two - day workshop saw sessions facilitated on sexual and reproductive health as well as literacy and leadership conducted by representatives of the GRPA and the RCC respectively. These sessions were very well received by the students.

The second day saw sessions with the staff on professionalism and leadership conducted by the CEO of the RCC. These sessions also saw the participation of Ms. Nandranie Conjah of the Women and Gender Equality Commission.

The third leg of the engagement with the NOC represents the formidable commitment of the Commission towards the institutional strengthening at the NOC.

RCC's Presence on the UNDP's MDGs Awards Committee

During the third quarter of 2014, the RCC participated in an awards committee that was tasked with adjudicating awards to both public and private sector actors and stakeholders who

have been engaged in sustained and stellar work in the advancement of the UN Millennium Development goals.

The RCC was initially represented on this committee by the CEO Mr. Amar Panday and then subsequently by Commissioner Sandra Hooper, and these persons contributed to a successful conclusion of those deliberations.

Second and third leg of the engagement with the Sophia Training Centre

During the third quarter of 2014, the RCC conducted the second and third legs of its engagement with the Sophia Training Centre.

These workshops focused predominantly on the youth clientele of the Centre. These sessions focused on personal development, leadership development and the UNCRC. The third leg of the engagement targeted the students who were selected to attend work study engagements. The third leg of the engagement featured a motivational presentation by the Speaker of the National Assembly the Hon. Raphael Trotman. These engagements were very well received by the student body of the Centre.

The Sophia Training Centre is a significant location of Guyana's at risk and disadvantaged children and youth. The engagement with the centre reflects the commitment of the commission to the empowerment of the student body of the Centre.

Face the Community meetings Conducted in Partnership with the Ministry of Education

During the third quarter of 2014, The RCC partnered with the Ministry of Education to participate in a number of face – the - community meetings in Grove (Region 4) and Zeeland (Region 5).

These meetings allowed the commissioners and CEO to interact with parents and other stakeholder on issues relevant to the education of Guyana's Children. These meetings were attended by Commissioners Pamela Nauth, Sandra Hooper and the CEO of the RCC Mr. Amar Panday.

At these meetings, the RCC took the opportunity to brief parents and other stakeholders on the work done by the commission. Commissioners also spoke to parents on the UNCRC and the requirements thereof.

The face the community meetings represented an important juncture vis a vis the relationship with the Ministry of Education as the Commission would move to cement other tangible initiatives in partnership with the Ministry of Education.

Child Participation Action Plan Workshop

During the third quarter of 2014, the RCC in partnership with UNICEF, hosted a Child Participation Action Plan workshop.

This workshop utilized the Child Participation Framework that was crafted in 2013 to come up with a National Child Participation Action Plan. This Action Plan will serve as a tangible blueprint and roadmap for establishing child participation in Guyana. The framework document has been shared with Members of Parliament, Government Ministers etc.

This workshop was facilitated by the CEO of the RCC Mr. Amar Panday along with vital support from other commissioners. The youth and child participants were drawn from each administrative region.

Engagement with Teachers of the Dharmic Rama Krishna Primary school

During the last quarter of 2014, the RCC conducted a UNCRC and capacity building workshop with the teachers of the Dharmic Rama Krishna Primary School.

This school falls under the jurisdiction of the Guyana Hindu Dharmic Sahha. The workshop was organized by Mrs. Sarojanie Rambarran, commissioner of the RCC and Board member of the Dharmic Rama Krishna Primary School. The session focused on professionalism in the teaching service and examined the articles of the CRC. The workshop was facilitated by the CEO Mr. Amar Panday with vital support from Commissioners

Rambaran and Hooper.

The workshop represents the commitment of the Commission to work with all faith based organizations in raising national consciousness with regard to the needs of the child and the UNCRC.

Second engagement with the senior staffers of the Ptolemy Reid Rehab Centre.

The RCC during the last quarter of 2014, conducted the second leg of the engagement with the senior staffers of the Ptolemy Reid Rehab Centre.

The engagement focused on the UNCRPD and the Acts pertaining to disabled children in Guyana. The workshop was organized by RCC commissioner and Director of the Ptolemy Reid Rehab Centre, Mrs. Cynthia Massay. This workshop was facilitated by the CEO Mr. Amar Panday with vital assistance from commissioners Massay and Rambaran.

The RCC will continue to work closely with the Rehab Centre and other similar institutions ensuring that Guyana's differently able children are offered the protection and empowerment enshrined in the UNCRC and UNCRPD.

Leadership and Website Launch Workshop

During the last quarter of 2014, the RCC conducted a leadership and Website launch workshop. The workshop saw the launch of the RCC's website www.rccgy.org. The workshop featured the participation of ten Georgetown Schools.

RCC contracted web designer Mr. Paramdeo Singh, briefed the participants on the myriad features of the website and moreover, how they can communicate with the Commission via the site. Participants also got an opportunity to make suggestions on the continued crafting and enhancement of the site.

The workshop also featured sessions by the CEO on leadership development, the UNCRC and the RCC's complaint mechanism. RCC commissioners Ms. Pamela Nauth and Mrs. Sarojanie Rambaran played instructive roles. UNICEF's communication programme officer Ms. Jewell Mbozi also attended.

The critical support of UNICEF is acknowledged in this important step for the RCC.

RCC presentation at the UNICEF/GOG mid term Review

During the last quarter of 2014, the RCC presented at the UNICEF/ GOG mid - term review, on the work undertaken by the Commission in partnership with UNICEF. This presentation was made by CEO of the RCC Mr. Amar Panday guided by Deputy Chairperson Mrs. Rosemary Benjamin Noble. The presentation focused on the three pillar areas of partnership between the Commission and UNICEF. These include:

- 1. Child Protection
- 2. Child Participation
- 3. Media Monitoring

The Mid - Term Review also featured presentations from the senior representatives of the Ministries of Health, Education, and Human Services and Social Security, all of whom detailed their ministries' accomplishments in partnership with UNICEF.

Workshop facilitated by UNICEF and the Governance Unit of the Office of the President on the reporting process attached to Guyana's treaty Obligations under the UNCRC.

During the last quarter of 2014, the RCC participated in a round table discussion on Guyana's treaty obligations under the UNCRC. The feature presentation was delivered by Ms. Gail Teixeira, Head of the Governance Unit of the Office of the President. Ms. Teixeira had disclosed that the reporting would contain a gamut of measures undertaken by the country in realizing the articles of the UNCRC.

The round table discussion was also attended by a number of other critical stakeholders with a material interest in the realization of the articles in the UNCRC. Such included the CCPA, GPF, Legal Aid etc.

Engagement with the Georgetown Schools

During the last quarter of 2014, the RCC embarked on a series of UNCRC/ Leadership workshops in

the secondary schools of Georgetown.

This engagement came out of a cultivated relationship with the Ministry of Education. The schools covered in the last quarter of 2014 are: Queen's College, Bishops' High School, Central High School and New Campbellville Secondary School. These workshops were facilitated by the CEO Mr. Amar Panday with vital support from the commissioners.

These workshops were intended to familiarize students with the articles of the convention as well to nurture a cadre of child and youth leaders who would, in turn, do further work in the dissemination of the convention. These workshops were also premised on the spirit and intent of the child participation philosophy.

Attendance and Participation at a Family Law Conference in Nassau Bahamas

During the last quarter of 2014, the RCC attended and participated in a Family Law Conference in Nassau Bahamas. Commissioner Sandra Hooper attended and represented the Commission.

This conference gave special focus to children in the observance of the 25th Anniversary of the adoption of the United Nations Convention on the Rights of the Child. The theme of the conference was "Our Children, an Endangered Species".

The Conference brought together representatives of the legal profession and other critical stakeholders involved in the enlivening of the articles of the UNCRC.

CHALLENGES AND SUCCESSES

The perennial challenge of insufficient resources remained in 2014. It was the hope of the RCC that it would be able to execute certain activities in outlying and remote areas, but these unfortunately suffered from the refusal of disbursement by the Ministry of Finance.

Generally, the stymicing of the exercise of autonomy by the RCC as guaranteed by the Constitution of Guyana, caused execution of its work plan to be at times difficult. Were it not for the dedication of commissioners, the CEO and staff of the RCC to the fundamental cause of the

rights of the child, very little work may have been done.

Regardless, however, of the foregoing frustrations, the RCC had the ever – present bolster of UNICEF, and the Commission was able to carry out other significant work.
