MEDICAL PRACTITIONERS (TEMPORARY REGISTRATION) ORDINANCE.

Mr. Cummings (Member for Labour, Health and Housing) gave notice of the following motions:—

"Whereas the Medical Practitioners (Temporary Registration) Ordinance, 1947 (No. 24) came into operation on the 26th of July, 1947;

And whereas section 5 of the said Ordinance provides that the Ordinance shall continue in force up to and including the thirty-first day of December, nineteen hundred and fifty-one, but that the Legislative Council may, prior to the expiration of this Ordinance, by resolution (which resolution shall be published in the Gazette) declare that it shall continue in force for a further period of one year from the date of that expiration and may from time to time prior to the expiration of that or any further continued operation, similarly declare that it shall continue for a further period of one vear:

And whereas by the Medical Practitioners (Temporary Registration) (Extension) Ordinance, 1954 (No. 6), the Medical Practitioners (Temporary Registration) Ordinance, 1947, has been continued in force as though that Ordinance had been continued in force by resolution of the Legislative Council in accordance with the provisions of section 5 thereof for the period commencing on the 1st January, 1954, and ending on the 31st December, 1954;

And whereas it is desirable that the Medical Practitioners (Temporary Registration) Ordinance, 1947, should continue in operation for a further period:

Now, therefore, be it resolved that the Medical Practitioners (Temporary Registration) Ordinance, 1947 (No. 24), shall continue in force for a further period of one year from the 1st January, 1955."

RENT RESTRICTION ORDINANCE.

"Whereas the Rent Restriction Ordinance, 1941 (No. 23 of 1941) came into operation on the 8th day of November, 1941;

And whereas section 16 of the said Ordinance, as amended by section 17 of the Rent Restriction (Amendment) Ordinance, 1947 (No. 13 of 1947) provides that the Ordinance shall continue in force up to and including the 31st day of December, 1951, but that, prior to the expriation thereof, the Legislative Council may, by resolution published in the Gazette, declare that the said Ordinance shall continue in operation for a further period of one year;

And whereas by annual resolutions the said Ordinance was continued in operation during the years 1952 and 1953; And whereas by the Rent Restriction (Continuance) Ordinance, 1954 (No. 1 of 1954) the Rent Restriction Ordinance, 1941 (No. 23 of 1941) was continued in force and deemed always to have been in force as though that Ordinance as amended had been continued in force by Resolution of the Legislative Council in accordance with the provisions of section 16 of that Ordinance for the period commencing on the 1st January, 1954, and ending on the 31st December, 1954;

And whereas it is expedient that the said Ordinance be continued in operation for a further period of one year:

Now, therefore, be it resolved that the Rent Restriction Ordinance, 1941 (No. 23 of 1941) shall continue in force for a further period of one year up to and including the 31st December, 1955,"

UNOFFICAL NOTICES

PEASANT LIVESTOCK DEVELOPMENT SCHEME.

Mr. Bobb gave notice of the following motions:

"Whereas all necessary steps should be taken to provide opportunities for more gainful employment;

And whereas there is a considerable number of actual and intending peasant livestock rearers who would welcome more remunerative schemes to expand the livestock industry;

And whereas such expansion will materially benefit the economy of the country:

Be it resolved:

That this Honourable Council requests the Governor in Council to examine the possibilities of establishing on some suitable site on the East Coast of Demerara a Peasant Livestock Development Scheme."

That this Council respectfully recommends that the Governor in Council investigate the possibilities of establishing in the Colony a factory for the manufacture of paints and by-products; and, if such investigation is favourable, to approach the Trade Commissioners for the British West Indies, British Guiana and British Honduras in the United Kingdom and Canada with a view to their interesting persons or concerns in establishing such a factory in the Colony."

Sir Frank McDavid: I beg to move he first reading of a Bill intituled:

"An Ordinance to provide for the establishment of a certain Drainage and Irrigation Area, the validation of the construction of certain works and for purposes connected therewith."

Mr. Cummings seconded,

Question put, and agreed to.

Bill read the first time.

PROPOSAL TO CLOSE SESSION

Mr. Speaker: Items 3, 4, 5 and 6 on the Order Paper will not be taken today. I would be glad if hon. Members would co-operate with a view of disposing of all business on the Order Paper, if possible, in order to conclude our First Session. It is desirable that there should be an end of this session this year. We must therefore endeavour to do as much business as we can before the year ends. We will try at any rate.

BRITISH GUIANA SANATAN DHARMA MAHA SABHA (INCORPORATION OF TRUSTEES BILL)

Mr. Sugrim Singh: I beg to move the second reading of the Bill intituled:

"An Ordinance to incorporate certain persons as Trustees of the body known as the British Guiana Sanatan Dharma Maha Sabha; to vest in such persons certain property; and for purposes connected with the matters aforesaid."

In moving the second reading of this Bill I wish to say that, as indicated in the Objects and Reasons attached to the Bill, the organisation known as the British Guiana Sanatan Dharma Maha Sabha, which has been operating in this Colony for about 20 years, has increased its work and now owns quite a few properties in the Colony. It has therefore become necessary to incorporate certain persons as Trustees so that the organisation can properly hold those properties. The organisation now controls 30 schools in the Colony and has distributed over \$2,750 provided by Government. There are also about 57 Temples in respect of which some of the lands have been donated to the organisation which desires to hold them properly. I formally move that the Bill be read a second time.

Mr. Correia seconded.

Question put, and agreed to.

Bill read a second time.

Council resolved itself into Committee to consider the Bill clause by clause, and approved of the Bill as printed without discussion.

Council resumed.

Mr. Sugrim Singh: I move that the Bill be now read a third time and passed.

Mr. Correia seconded.

Mr. Speaker: The Bill has been published a long time. Has anyone any objection to the third reading being taken today? I will put the question "That the Bill be read a third time and passed."

Agreed to.

Bill read a third time and passed.

Mr. Speaker: After tomorrow we must arrange the business of the Council, as it is desirable to conclude the session this year.

The Attorney General: As far as is practicable I do not know if it is necessary to conclude the session in the current year. We have had in the past to continue a few months after the close of the year in order to conclude essential business.

Sir Frank McDavid: Do I understand we are about to close the present session?

Mr. Speaker: It all depends on what Members wish.

Sir Frank McDavid: I know it is impractical to conclude the business of the session this year. The Budget is to be presented tomorrow, and that cannot be completed until about the second month in next year.

Mr. Speaker: In speaking I am referring to other Bills. The Budget has to be deferred.

The Chief Secretary: I feel it may be possible to dispose of some of these Bills outstanding, and so we must endeavour to deal with them as early as possible this year.

The Financial Secretary: I have two Bills which I hope to conclude on Monday.

Mr. Speaker: Council is adjourned until tomorrow at 2 o'clock.
