BRITISH EMPIRE DEFINITION BILL.

Mr. Mc DAVID (Colonial Treasurer): I move that "A Bill to allow and confirm certain additional expenditure incurred in the year ended thirty-first day of December, 1932," be now read a third time.

Question "That this Bill be now read a third time and passed" put, and agreed to.

OPTICIANS BILL.

Mr. CANNON: Your Excellency, be fore taking Order IV.—(A Bill to make provision for the registration of Opticians, to regulate the practice of sight-testing and for purposes incidental thereto).—I have been asked by my hon. colleague the Member for Georgetown South to ask that this matter be allowed to stand down to the next sitting of the Council, which I understand will be next week.

THE PRESIDENT: Will it be helpful if the hon. Surgeon-General states what Government's proposals are, or will it be better to wait?

Mr. CANNON: Speaking for myself I

have no objection, but it will be best to wait until next week.

THE PRESIDENT: Government is quite willing to postpone it. The agenda is very short for to-day as we have left the rice question for next week. There is no difficulty in taking it next week. I think in the circumstances we will take it next week. Perhaps you (Mr. Cannon) will get into touch with the hon. Member who has asked for the postponement and let him know what is proposed, so as to savetime in the debate.

Mr. CANNON: I understand it is the hon. Member for Berbice River who asked his colleague on his left (who is ill) and in turn asked the hon. Member for Georgetown South, and that is how I have come into it.

THE PRESIDENT: See the hon. Member who asked you and let him pass it on. (Laughter).
