# ITEM 1 - REPRESENTATION OF THE PEOPLE (ADAPTATION AND MODIFICATION OF LAWS) BILL 1973 - Bill No. 9/1973 published 26.5.73

# ITEM 2 - TRAVEL VOUCHER TAX BILL 1973 - Bill No. 7/1973 published 22.5.73

In accordance with article 80(2) of the Constitution, the Minister of Finance and Trade signified Cabinet's recommendation and moved the second reading of the following Bill:

A BILL intituled AN ACT TO PROVIDE FOR THE IMPOSITION AND COLLECTION IN GUYANA OF A TAX ON TRAVEL TICKETS USED FOR THE PURPOSE OF TRAVEL ERIGINATING FROM GUYANA.

Mr. Ram Karran, Mrs. DaSilva and the Leader of the Upposition spoke to the motion.
