INTRODUCTION OF BILLS

Presentation and First Reading

INCOME TAX (AMENDMENT) BILL 1973 - Bill No. 10/1973 published 1.6.73

The Minister of Finance and Trade, on behalf of the Government, presented the following Bill which was read the first time:

A BILL intituled AN ACT TO AMEND THE INCOME TAX ORDINANCE.

MOTION TO APPROVE REMISSION OF STAME DUTY ON PRIVATE BILL

Mr. Bissember moved and Miss Ackman seconded the following motion which was put and <u>carried</u>:

WHEREAS, in accordance with Standing Order
No. 57(5)(b) of the Standing Orders of the National
Assembly, and of section 9(33) of the Tax Ordinance,
Chapter 298, the Promoters of the Private Bill to
amend the Assemblies of God (Incorporation) Ordinance,
1958, paid to the Accountant General the prescribed
stamp duty of \$100.00;

AND WHEREAS the Bill was enacted by Parliament on the 9th of March, 1973;

AND WHEREAS in accordance with section 9(33) of the Tax Ordinance, Chapter 298, the National Assembly may remit payment of the stamp duty:

BE IT RESOLVED:

That this National Assembly approves of the remission to the Promoters of the Assemblies of God (Incorporation)(Amendment) Bill 1973, of the stamp duty of \$100.00 paid to the Accountant General in respect of the Bill.
