On a motion by the Financial Secretary seconded by the Attorney-General, Council adopted the following Resolution:-

RESOLVED, That pending the passing of the 1959 Estimates, this Council approves of such expenditure for Recurrent and Development Expenditure in 1959 as may be required for the maintenance of existing services and the continuance of works in progress on the basis approved by this Council in the Annual and Supplementary Estimates for the year 1958.

Item 4 - MOTION TO CONTINUE THE MEDICAL PRACTITIONERS (TEMPORARY REGISTRATION) ORDINANCE.

On a motion by the Minister of Labour, Health and Housing seconded by the Minister of Community Development and Education, Council adopted the following Resolution:-

RESOLVED, That the Medical Practitioners (Temporary Registration) Ordinance, Chapter 135, shall continue in force for a further period of one year from the 1st January, 1959.

Item 5 - MOTION TO CONTINUE THE RENT RESTRICTION ORDINANCE.

On a motion by the Minister of Labour, Health and Housing seconded by the Minister of Communications and Works, Council adopted the following Resolution:-

RESOLVED, That the Rent Restriction Ordinance, Chapter 186, shall continue in force for a further period of one year up to and including the 31st day of December, 1959.

Item 6 - INDIAN LABOUR (AMENDMENT) BILL, 1958 - Bill No. 34/1958

On a motion by the Minister of Community Development and Education seconded by the Minister of Trade and Industry, the BILL intituled AN ORDINANCE TO AMEND THE INDIAN LABOUR ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 7 - ANTIBIOTICS (AMENDMENT) BILL, 1958 - Bill No. 33/1958.

On a motion by the Minister of Labour, Health and Housing seconded by the Minister of Community Development and Education the BILL intituled AN ORDINANCE TO AMEND THE ANTIBIOTICS ORDINANCE TO PROVIDE FOR CERTAIN EXEMPTIONS was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 9 - NEW AMSTERDAM ELECTRIC LIGHTING ORDER (EXTENSION) (AMENDMENT) BILL, 1958 - Bill No. 32/1958.

On a motion by the Minister of Communications and Works seconded by the Minister of Natural Resources, the BILL intituled AN ORDINANCE TO AMEND THE NEW AMSTERDAM ELECTRIC LIGHTING ORDER (EXTENSION) ORDINANCE, 1957 was read a second time and was thereafter taken through its remaining stages and passed as printed.
