Item 2 - RICE MARKETING (AMENDMENT) BILL, 1960 - Bill No. 12/1960.

Council resumed the debate on the motion for the second reading of the following Bill:

A BILL intituled AN ORDINANCE FURTHER TO AMEND THE RICE MARKETING ORDINANCE AND TO MAKE A MINOR CONSEQUENTIAL AMENDMENT TO THE BRITISH GUIANA RICE PRODUCERS ASSOCIATION ORDINANCE.

Thereafter, the Bill was read a second time.

Council then resolved itself into a Committee to consider the Bill clause by clause.

In Committee

Clause 1 - Short Title - was passed as printed.

Clause 2 - was passed as printed.

- The Minister of Trade and Industry moved Clause 3 the following amendments:-
 - (i) Substitution of the word "persons" for the words "rice producers" between the words "twelve" and "appointed" in the new subsection (2)(b).
 - (ii) Substitution of the word "person" for the words "rice producer" between the words "one" and "nominated" in the new subsection (2)(b)(iii).
 - (iii) Substitution of the words "experienced in marketing" for the words "nominated as being persons experienced in marketing by the rice producers appointed under the preceding paragraph" in the new subsection (2)(c).

Mr. Davis moved the following amendments:-

- (i) Substitution of the word "seven" for the word "nine" in the new subsection (2)(b)(i).
- (ii) Substitution of the word "four" for the word "two" in the new subsection (2)(b)(ii).

The Minister of Trade and Industry moved the following further amendments:-

- (i) Substitution of the word "eight" for the word "nine" in the new subsection (2)(b)(i).
- (ii) Substitution of the word "three" for the word "two" in the new subsection (2)(b)(ii).
- (iii) Substitution of the word "paragraph" for the word "paragraphs" and Deletion of "and (c)" in the first line of the new subsection (3).
 - $\underline{\text{Mr. Davis}}$ moved the following further amendment: $\underline{\text{Deletion}}$ of paragraph (b) of the new subsection (3).

After discussion, Clause 3 was put and carried with the amendments moved by the Minister of Trade and Industry.

Clauses 4 to 12 - were passed as printed.

TITLE - was passed as printed.

Council resumed.

Thereafter, on a motion by the Minister of Trade and Industry, the Bill was read the third time and passed as amended in Committee.

Item 3 - GEORGETOWN SEWERAGE AND WATER (AMENDMENT) BILL. 1960 - Bill No. 11/1960.

On a motion by the Minister of Community Development and Education seconded by the Minister of Natural Resources, the BILL intituled AN ORDINANCE TO AMEND THE GEORGETOWN SEWERAGE AND WATER ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

<u>Item 4 - INTERPRETATION (AMENDMENT) BILL, 1960 - Bill No. 13/1960.</u>

On a motion by the Attorney-General seconded by the Financial Secretary, the BILL intituled AN ORDINANCE TO AMEND THE INTERPRETATION ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed with the following amendment in Committee:-

Clause 3 - Substitution of the following for the new subsection 9A:-

"Time for performance of act in relation to Sunday or public holiday.

9A(1) Where by or under any Ordinance anything is required or authorised to be done on a certain day, then if that day is a Sunday or public holiday, unless the contrary intention appears, the thing shall be deemed to have been done in due time if it is done on the next following day which is not a Sunday or public holiday.

(2) Where by or under any Ordinance, any period of time dating from a given day, act, or event, is prescribed or allowed for any purpose, and the last day of any such period falls on a Sunday or public holiday, unless the contrary intention appears, the period shall include the next following day which is not a Sunday or public holiday."

That this Council recommends the repeal of the Land Bonds Ordinance, 1959 (No. 21).
