- (vi) What are the comparative unit rates for cleaning Drains in each of the ten (10) Regions?

- (ii) No. All contracts undertaken in Region No. 10 by the National Drainage and Irrigation Board are approved by the Ministry of Agriculture Procurement Board. These contracts are procured as follows:
  - Project proposals from CDC and any other Groups must be acknowledged by the National Director of Community Development Councils before consideration is given for them to be engaged in any Drainage and Irrigation works.
  - These proposals are referred to the RDC No. 10 for recommendation and to avoid duplication of works.
  - The recommended proposals are then technically examined and submitted to the
     Ministry of Agriculture Procurement Board for approvals.

- (iii) Contracts awarded by the National Drainage and Irrigation Board are being monitored by the NDIB, RDC No. 10 and CDC groups.

- (v) There is no fix unit rate paid for cleaning/excavation of drains in Linden. The unit rate differs for each project. The Unit rate is calculated based on the project size, complexity, condition and nature of works to be undertaken.
