Citation.

Order No. 47 of 1990 1. This Order, which amends the Local Democratic Organs (Areas) Order, may be cited as the Local Democratic Organs (Areas) (Amendment) Order 2018.

Termination of neighbourhood Burro-Burro and the formation of two new neighbourhoods.

> Order No. 47 of 1990

- 2. (1) The neighbourhood known as Burro-Burro of the community of Upper Burro-Burro/Central Rupununi, in Region 9, established under clauses 5, 6 and 7 of the Principal Order, and comprising the areas of the following people's co-operative units stands terminated
 - (a) Upper Burro-Burro;
 - (b) Right Bank Rupununi/Yupukari;
 - (c) Right Bank Surama;
 - (d) Left Bank Mauri; and
 - (e) Aranaputa.
- (2) Notwithstanding the termination of the neighbourhood of Burro-Burro, the areas of the people's co-operative units of which Burro-Burro comprised and which are described in the Annexure IX of the Fifth Schedule to the Principal Order shall comprise the neighbourhoods of Aranaputa/Upper Burro-Burro and Annai in the manner set out in clauses 3 and 4.

Areas of Aranaputa/Upper Burro-Burro.

- 3. The neighbourhood of Aranaputa/Upper Burro-Burro shall comprise the areas of the
 - (a) Upper Burro-Burro people's co-operative unit; and
 - (b) Aranaputa people's co-operative unit.

Areas of Annai.

- 4. The neighbourhood of Annai shall comprise the areas of the
 - (a) Right Bank Rupununi/Yupukari people's co-operative unit;
 - (b) Right Bank Surama people's co-operative unit; and
 - (c) Left Bank Mauri people's co-operative unit.
