

ORDER

THE ELECTRICITY ORDINANCE, 1957

(No. 34 of 1957).

UNDER SECTION 28 OF THE ELECTRICITY ORDINANCE 1957 AND PURSUANT TO CLAUSE 28 OF THE ELECTRICITY ORDER IT IS HEREBY ORDERED AS FOLLOWS :—

1. This Order which amends the Electricity Order* may be cited as the Electricity (Amendment) Order, 1970,

2. The Principal Order is hereby amended in the following respects —

- (a) by the insertion of the word “first” before the word “schedule” and the word “FIRST” before the word “SCHEDULE”, wherever they respectively appear;
- (b) by the substitution for paragraph (2) of clause 28 of the following paragraph —

“(2) In respect of the said duties an inspector shall be entitled to take such fees as are set out in the second schedule which may from time to time be amended by the Minister, who may also prescribe the manner in which and the times at which any such duties are to be performed.”; and

- (c) by the addition thereto of the provisions set out in the schedule.

3. The fees to which the Government Electric Inspector is entitled as prescribed on the 27th November, 1933 for the purposes of clause 28 of the Principal Order are hereby revoked and the fees set out in the second schedule to the Principal Order are substituted therefor.

SECOND SCHEDULE

CL 28(2)

FEEES TO WHICH THE GOVERNMENT ELECTRIC INSPECTOR SHALL BE ENTITLED IN RESPECT OF HIS DUTIES UNDER THE ELECTRICITY ORDER.

NATURE OF DUTY	FEES
(1) For inspecting and/or testing any consumer's electric light and power installation or any part thereof whether new or old. (If on inspection the installation is found to be not fit for approval the fee for inspection as above defined shall nevertheless be paid and shall also be paid for subsequent inspection required to be made by the inspector for the purpose of issuing the usual certificate of approval).	\$1.00 plus 50 cents for every outlet covered by the inspector's certificate of approval.
(2) For testing and certifying the accuracy of any electric meter	\$5.00
(3) For testing any discharge lamp	\$5.00
(4) For testing any generator or motor for continuity and insulation	\$5.00
(5) For testing the capacity etc. of any dynamo or motor	\$10.00
(6) (a) For testing any transformer not exceeding 1 KVA)	\$2.00
(b) For testing any transformer exceeding 1 KVA	\$2.50
(7) For special inspection	\$10.00
(8) For special testing	\$10.00
(9) For inquiring and reporting as to the cause of any accident due to electrical causes	\$25.00
(10) Testing condition of earth connection	\$2.50
(11) Testing to ascertain amount of current passing from the earth conditions	\$2.50
(12) Testing electrical equipment of any motor vehicle for conductivity or insulation	\$5.00
(13) For testing "pressure" at any consumer's premises	\$2.50
(14) For inspecting any temporary installation or part thereof.	\$5.00 for the first Kilowatt or part thereof and \$1.00 for every additional Kilowatt or part thereof."
