THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

(Chapter 280)

UNDER SECTION 47 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE THE FOLLOWING ORDER HAS BEEN MADE BY THE COMMISSIONER OF POLICE WITH THE APPROVAL OF THE MINISTER :—

1. This Order may be cited as the Motor Vehicles and Road Traffic (Prohibition of Traffic) (Sea-Wall/East Coast Public Road) Order 1973 and shall come into operation on 15th March, 1973.

2. No vehicle being a goods vehicle, motor bus, motor tractor, or a vehicle drawn by an animal, shall proceed in either direction along that portion of the Sea-Wall public road between its junction with High Street, Kingston, and its junction with Vlissengen Road, Georgetown, other than for the purpose (the proof whereof shall lie on the driver of the vehicle) of enabling repairs to be effected to another vehicle, the sea defences, or the aforementioned portion of the Sea-Wall public road, or for gaining access to, or making egress from, any premises situated along the said portion of public road.

3. No vehicle drawn by an animal shall, during the following period, that is to say —

- (a) commencing at 6 o'clock in the forenoon and ending at 8.30 o'clock in the forenoon of every day, except Sunday;
- (b) commencing at 11 o'clock in the forenoon and ending at 1.00 o'clock in the afternoon of every day, except Sunday; and
- (c) commencing at 3.30 o'clock in the afternoon and ending at 5.00 o'clock in the afternoon of every day, except Saturday and Sunday,

proceed in either direction along that portion of the East Coast Public Road extending from Vlissengen Road, Georgetown, to the bridge across the side line trench between Beterverwagting Village District and Plantation La Intention.

#### EXPLANATORY NOTE

(This Note is not part of the Order)

This Order provides for the regulation of vehicular traffic along the sea Wall Public Road from its junction with High Street to its junction with Vlissengen Road.

The Order also provides for the regulation of the use by animal drawn vehicles of that portion of the East Coast Public Road extending from Vlissengen Road to the point on that road where the Western boundary of Beterverwagting Village District commences.
