THE TRADE ORDINANCE, 1958

(No. 34 of 1958)

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969\*, may be cited as the Trade (Control of Prices) (Amendment) (No. 21) Order 1973.

2. Part A of the first schedule to the Principal Order is hereby amended by the substitution in the respective columns thereof for the particulars relating to the article of foodstuff numbered 7 (Salt) and sub-heading (a) of the article of foodstuff numbered 37 (Jelly Crystals), of the particulars as set out in the respective columns against the said articles of foodstuff numbered 7 (Salt) and 37 (Jelly Crystals) in Part A of the schedule to this Order.

3. Part B of the first schedule to the Principal Order is hereby amended by the substitution in the respective columns thereof for the particulars relating to sub-heading (a) of the article of foodstuff numbered 37 (Jelly Crystals), of the particulars as set out in the respective columns against the said article of foodstuff numbered 37 (Jelly Crystals) in Part B of the schedule to this Order.
