THE CONSUMPTION TAX ACT, 1969 (No. 13 of 1969)

IN BIERCISE OF THE POWER VESTED IN THE MINISTER BY SECTION 4 OF THE CONSUMPTION TAX ACT, 1969, I MAKE THE FOLLOWING ORDER: -

- This Order may be cited as the Consumption Tax (Amendment)
 Order 1973.
- 2. During the continuance in force of this Order tax shall be payable on the goods specified in the First Schedule to this Order, at the respective rate so specified, other than on goods exempt from duties of customs under the provisions of Part III of the First Schedule to the Customs Ordinance, Chapter 309 or under any law from duties of exise.
- 3. References to Tariff Heading Numbers and Statistical Classification Numbers in the Schedule are to those numbers prescribed in the First Schedule to the Customs Ordinance, Chapter 309 and specified in the General Provisions to Part I thereof as being based on the Brussels Nomenclature and the Standard International Trade Classification, Revised. The prefix "Ex" to those numbers indicates that the articles therein described comprise only part of the items covered by those classification numbers in Part I of the First Schedule to the Customs Ordinance
 - 4. The Orders specified in the Second Schedule are revoked.
