IN THE EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO THE CENTRAL HOUSING AND PLANNING AUTHORITY, BY NOTIFICATION UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER: -

Citation.

 This Order may be cited as the Central Housing and Planning Authority (Transfer of Property) Order 2008.

Interpretation.

- 2. In this Order-
 - (a) "Agreements" means the Memorandum of Agreements of Sale made on the 3rd day of November, 2006, 6th day of November 2006 and the 23rd day of November, 2006 between the CHPA and the Purchasers;

"CHPA" means the Central Housing and Planning Authority, a body corporate incorporated under the Provisions of the Housing Act, Chapter 36:20 of the Laws of Guyana with its registered office at Lot 41 Brickdam and United Nations Place, Stabroek, Georgetown, Demerara.

Schedule

- (b) "Properties" means the properties described in the Schedule, being properties belonging to CHPA;
- (c) "Purchasers" means the list of persons mentioned in the Schedule, whose properties were compulsory acquired by the Government of Guyana for the Berbice River Bridge and who were relocated to Ketting No. 2 Village, West Coast Berbice.

Transfer of Property.

3. Pursuant to the Agreements and subject to the representations, covenants and the terms and conditions specified therein, the Properties are hereby transferred to the Purchasers, the name of each Purchaser being mentioned at the beginning of each lot being transferred.
