## **ORDER**

#### MADE UNDER

# THE PUBLIC AND JUDICIAL OFFICERS (REMUNERATION) ORDINANCE, 1962,

(No. 26 of 1962)

## UNDER SECTION 3 OF THE PUBLIC AND JUDICIAL OFFICERS (REM-UNERATION) ORDINANCE, 1962, IT IS HEREBY ORDERED BY THE MINISTER OF FINANCE AS FOLLOWS:—

- 1.(1) This Order may be cited as the Public and Judicial Officers (Allowances) Order, 1963.
- (2) This Order shall, in respect of the provisions herein contained relating to the payment of allowances to -
  - (a) the members of the Public Service Commission, be deemed to have come into operation on the 12th September, 1961;
  - (b) the members of the Police Service Commission, be deemed to have come into operation on the 31st October, 1961.
- 2. In this Order, the expression "Service Commission" means the Judicial Service Commission or the Public Service Commission or the Police Service Commission established under the Constitution of British Guiana.
- 3. The Governor shall be paid a duty allowance of nine thousand, six hundred dollars per annum.
- 4. The Chief Justice of the Supreme Court shall be paid a chauffeur allowance of ninety dollars per month.
- 5.(1) Every judge of the Supreme Court, the Director of Public Prosecutions, the Chairman of the Public Service Commission, and every other member of the said Commission performing full time duties with the Commission, shall each be paid a commuted travelling allowance of twenty-five dollars per month in respect of the use of his motor car on official duty.
- (2) In addition to the amounts provided for under the last preceding paragraph, the holder of an office referred to therein shall be entitled to be paid for travelling done outside the City of Georgetown in connection with his official duties as follows
  - (a) travelling allowance at the rate of 28 cents per mile for every mile travelled in a car of over 12 h.p. owned by him and certified by him to that effect:
  - (b) travelling allowance at the rate of 19½ cents per mile for every mile travelled in a car of 12 h.p. or under owned by him and certified by him to that effect;
  - (c) reasonable travelling expenses incurred where he is obliged to travel by other means of transport as a result of the area from which he is required to travel for the purpose of performing his

official duties, not being served by transport services operated by the Transport and Harbours Department:

Provided that the provisions of this paragraph shall not apply where the holder of an office aforesaid lives outside the City of Georgetown and travels into the said City for the purpose of performing his official duties.

- (3) Every person referred to in paragraphs (1) and (4) of this article shall, in connection with the performance of his official duties, be entitled to travel at the expense of the Government by transport services operated by the Transport and Harbours Department.
- (4) The provisions of sub-paragraphs (a), (b) and (c) of paragraph (2)—of-this\_article shall apply for the purpose of the payment of travelling allowance or travelling expenses, as the case may be, to the appointed member of the Judicial Service Commission, every member of the Public Service Commission performing part-time duties with the said Commission and every appointed member of the Police Service Commission, living outside the City of Georgetown, in respect of their attendance in the City of Georgetown at meetings of the Service Commissions of which they are members.
- (5) Any person referred to in the last preceding paragraph shall, where he is required to travel to any other part of British Guiana in connection with his official duties with the Service Commission of which he is a member, be entitled to be paid travelling allowance at the appropriate rate specified in subparagraph (a) or (b) of paragraph (2) of this article, or his reasonable travelling expenses where the provisions of sub-paragraph (c) of paragraph (2) of this article apply.
- 6.(1) The judges of the Supreme Court and the Director of Public Prosecutions shall be paid subsistence allowance at the rate of \$4.80 per day for the first 14 days and \$3.60 per day thereafter, subject to the conditions of payment from time to time applying to officers in the public service.
- (2) The Chairman of the Public Service Commission shall be paid subsistence allowance at the rate of \$4.50 per day for the first 28 days, \$3.50 per day for the next 28 days, and \$2.25 per day thereafter, subject to the conditions of payment from time to time applying to Heads of Departments in the public service.
- (3) The appointed member of the Judicial Service Commission, every member of the Public Service Commission other than the Chairman thereof, and every appointed member of the Police Service Commission, shall be paid subsistence allowance at the rate of \$4.00 per day for the first 28 days, \$3.00 per day for the next 28 days and \$2.00 per day thereafter, subject to the conditions of payment from time to time applying to officers in the public service to whom the aforesaid rates are payable as subsistence allowance.
