## ORDER

# THE ANIMALS DISEASES ORDINANCE (Chapter 258)

- UNDER SECTIONS 2 AND 13 OF THE ANIMALS DISEASES ORDINANCE, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF THE FOLLOWING ORDER HAS BEEN MADE BY THE GOVERNOR'S DEPUTY.
- 1. This Order may be cited as the Poultry Carcasses (Conditions of Importation) Order, 1965.
  - 2. In this Order
    - "eviscerated" means having had the viscera removed;
    - "plucked" means having had all feathers and feather shafts removed;
    - "poultry" means any live bird of the following species, that is to say, any domestic fowl, turkey, goose, duck, guinea fowl, pheasant or pigeon.
  - 3. For the purposes of this Order
    - (a) poultry shall be included in the definition of the expression "animal" in section 2 of the Animals Diseases Ordinance\*;
    - (b) Newcastle Disease, fowl pest, fowl typhoid and pullorum disease are hereby declared to be diseases within the meaning of the Animals Diseases Ordinance.
- 4. Poultry carcasses shall not be imported into British Guiana unless they have been plucked, eviscerated, and the head and feet removed.
- 5. Poultry carcasses or parts of poultry carcasses shall not be imported into British Guiana from any country other than those countries specified in the schedule to this Order.
- 6. The importation into British Guiana of poultry feathers or the viscera (or any part thereof) of the poultry is hereby prohibited. \*Cap. 258.

- 7. Poultry carcasses or parts of poultry carcasses imported from any of the countries specified in the schedule to this Order shall be accompanied by a certificate of health signed by the proper authority in the country of origin to the effect that the poultry carcasses or parts of poultry carcasses emanated from flocks free from Newcastle Disease, fowl pest, fowl typhoid and pullorum disease.
- 8. The Importation of Poultry Carcasses (Control) Order. 1956\*\*. is hereby revoked.
