ORDER Made Under THE MINING ACT (No. 20 of 1989)

# IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 10 OF THE MINING ACT 1989, I HEREBY MAKE THE FOLLOWING ORDER:

Citation & Commencement.

1. This Order may be cited as the Prospecting and Mining of Minerals Reservation Order 2019 and shall be deemed to come into effect on the 9th day of November 2011.

Reservation

- From the effective date of this Order, the area hereinafter described in the Schedule below shall be reserved.
- 3. From the effective date of this Order, there shall be no prospecting or mining for any mineral within the area described in the Schedule PROVIDED THAT that the Minister may direct that prospecting or mining operations shall be carried on only by the Government, or by a public corporation, or by a corporate body in which the controlling interest vests in the State or in any agency on behalf of the State.

#### Schedule 1

#### **Description of Reserved Area**

Tract of state land located in the Cuyuni Mining District No. 4 as shown on Terra Surveys Topographic Map 22SE, at scale 1: 50,000 with reference point 'X' located at the confluence of the Paruima River and the Uluk River with geographical co-ordinates of longitude 61°3'5'W and latitude 5°54'58"N.

Thence at true bearing of 341°, for a distance of approximately 17 miles 457 yards, to point of commencement

Point A, located at geographical coordinates of longitude 61°8'8"W and latitude 6°10'42"N, thence at true bearing of 46°, for a distance of approximately 768 yards, to Point B, located at geographical coordinates of longitude 61°7'51"W and latitude 6°10'58"N, thence at true bearing of 125°, for a distance of approximately 1460 yards, to Point C, located at geographical coordinates of longitude 61°7'15"W and latitude 6°10'33"N, thence at true bearing of 149°, for a distance of approximately 1139 yards, to Point D, located at geographical coordinates of longitude 61°6'58"W and latitude 6°10'4"N, thence at true bearing of 223°, for a distance of approximately 1205 yards, to Point E, located at geographical coordinates of longitude 61°7'22"W and latitude 6°9'38"N, thence at true bearing of 277°, for a distance of approximately 578 yards, to Point F, located at geographical coordinates of longitude 61°7'40"W and latitude 6°9'40"N, thence at true bearing of 209°, for a distance of approximately 1171 yards, to Point G located at geographical coordinates of longitude 61°7'56"W and latitude 6°9'10"N, thence at true bearing of 209°, for a distance of approximately 1497 yards, to Point H, located at geographical coordinates of longitude 61°8'18"W and latitude 6°8'31"N, thence at true bearing of 154°, for a distance of approximately 1032 yards, to Point I, located at geographical coordinates of longitude 61°8'5"W and latitude 6°8'4"N, thence at true bearing of 251°, for a distance of approximately 847 yards, to Point J, located at geographical coordinates of longitude 61°8'28"W and latitude 6°7'55"N, thence at true bearing of 202°, for a distance of approximately 730 yards, to Point K, located at geographical coordinates of longitude 61°8'37"W and latitude 6°7'35"N, thence at true bearing of 197°, for a distance of approximately 1515 yards, to Point L, located at geographical coordinates of longitude 61°8'50"W and latitude 6°6'52"N, thence at true bearing of 196°, for a distance of approximately 645 yards, to Point M, located at geographical coordinates of longitude 61°8'55"W and latitude 6°6'34"N, thence at true bearing of 174°, for a distance of approximately 1 mile 871 yards, to Point N, located at geographical coordinates of longitude 61°8'47"W and latitude 6°5'17"N, thence at true bearing of 191°, for a distance of approximately 671 yards, to Point O, located at geographical coordinates of longitude 61°8'51"W and latitude 6°4'57"N, thence at true bearing of 191°, for a distance of approximately 1 mile 246 yards, to Point P, located at geographical coordinates of longitude 61°9'3"W and latitude 6°3'59"N, thence along the right bank of the Tshuau River for a distance of approximately 12 miles 598 yards to the point of commencement at Point A.
