## REGULATIONS

## MADE UNDER

THE STATISTICS ORDINANCE, 1965, (No. 14 of 1965).

UNDER SECTION 15 OF THE STATISTICS ORDINANCE AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, THE FOLLOWING REGULATIONS ARE HEREBY MADE BY THE MINISTER FOR THE TIME BEING CHARGED WITH RESPONSIBILITY FOR STATISTICS:—

- 1. These Regulations may be cited as the Statistics (Agricultural Census) Regulations, 1968.
  - 2. In these Regulations
    - "census" means the agricultural census directed to be taken by the Agricultural Census Order, 1968;
    - "holder" means the person who has the economic and technical initiative and responsibility for the operation of the holding and who operates the holding directly or through some other person and in cases where the holding is under the control or administration of a Ministry or Division of a Ministry, includes the person for the time being directly responsible for the administration of any Ministry or Division of a Ministry;
    - "holding" means
      - (a) the aggregate of land without regard to title or tenure and which is under the control of a holder as one business unit; or
      - (b) the livestock or poultry kept by a holder even though he may not have any land under his control.
- 3. (1) The particulars to be supplied on the taking of the census by a holder to whom this regulation applies shall be in respect of any or all of those matters connected with agriculture as set out in regulation 4 of these Regulations, and shall be supplied in such form and detail as the Statistician may, from time to time, direct.
  - (2) This regulation applies to any holder
    - (a) cultivating land for profit, research, experiment or subsistence; or
    - (b) rearing livestock or poultry.
- 4. Any holder on being required to do so by the Statistician shall furnish —

- (a) in respect of the household to which he belongs, the name, address, age, sex and main occupation of the members thereof;
- (b) in respect of his holding
  - (i) the area of the holding and the form of tenure thereof;
  - (ii) the area of cultivated and uncultivated land;
  - (iii) the number of parcels into which his cultivated land is divided;
  - (iv) the area of cultivated land irrigated and the source of such irrigation;
  - (v) the area of cultivation land provided with drainage facilities and the form of such drainage facilities;
  - (vi) the names of annual (catch) and perennial (permanent) crops harvested, the quantity harvested, the area harvested, the quantity sold and the quantity used for home consumption;
  - (vii) the number of livestock and poultry on the holding;
  - (viii) the volume of production of livestock and poultry products;
    - (ix) the quantity of food purchased for livestock and poultry;
    - (x) the number of workers employed on the holding, their sex, age, and the number of days worked by them;
  - (xi) details of animal or mechanical power used;
  - (xii) the amount and type of equipment and installations on the holding;
  - (xiii) the quantity of fertilizers, insecticides and weedicides used, and the area on which they have been used;
    - (xiv) the association of the holding with other industries;
    - (xv) the sources from which agricultural information was obtained.
