REGULATIONS

MADE UNDER

THE MINING (CONSOLIDATION) ORDINANCE, (Chapter 175).

UNDER SECTION 98 (1) OF THE MINING (CONSOLIDATION) ORDINANCE, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL:—

- 1. These Regulations may be cited as the Mining (Amendment) Regulations, 1954, and shall be construed and read with the Mining Regulations, 1931, hereinafter referred to as the Principal Regulations.
- 2. Regulation 2 of the Principal Regulations is hereby amended—
 - (a) by the insertion after the definition of the words
 "Licence and Claim Licence" of the following
 definition—
 "River location licence" means a licence issued
 under Part III of the Mining (Consolidation)

Ordinance, Chapter 175, in respect to any river or portion thereof; and "river location" means the area of any land or water in respect of which a river location licence is issued;" and,

- (b) by the insertion after the words "dredging concession" in the definition of the word "Claim" of the words "or river location licence".
- 3. Regulation 8 of the Principal Regulations is hereby amended by the insertion after the words "three inches square" in sub-regulation (1) of the words "and in the case of a river location, not less than six inches in diameter," and by the insertion after the words "nine inches by six inches" in sub-regulation (2) of the words "and in the case of a river location, not less than three feet square,".
- 4. Regulation 12 of the Principal Regulations is hereby amended—
 - (a) by the insertion after the words "No claim" of the words "other than a river location"; and
 - (b) by the substitution of a semi-colon for the full-stop after the word "wide" and by the addition thereafter of the words "and no river location shall be longer than one mile measured along the bank of the river or creek as the case may be,"

5. Regulation 13 of the Principal Regulations is hereby amended by re-numbering the regulation as sub-regulation (1) and by the addition thereto of the following sub-regulation —

"(2) The side-lines of a river location shall be fixed at the low water mark on each bank of the river or creek as the case may be and the end-lines by straight lines between corner marks."

6. Sub-regulation (1) of regulation 14 of the Principal Regulations is hereby amended by the insertion after the words "in Form No. 3" of the words "or in the case of a river location, in Form No. 3A,".

7. Sub-regulation (1) of regulation 22 of the Principal Regulations is hereby amended by the insertion after the words "in Form No. 6" of the words "or in the case of a river location, in Form No. 6A.".

8. Regulation 55 of the Principal Regulations is hereby amended by the insertion after the words "dredging concession"

of the words "or river location".

9. The First Schedule to the Principal Regulations is hereby amended by the insertion after Form No. 3 and Form No. 6 of Form No. 3A and Form No. 6A respectively as set out in the Schedule to these Regulations.

10. The Second Schedule to the Principal Regulations is hereby amended by the addition thereto of the following items:

"For filing a notice of location and application for a river location licence

\$2.00

"For a river location licence for each financial year or part thereof \$20.00"

REGULATIONS

MADE UNDER

THE CROWN LANDS ORDINANCE, (Chapter 171).

UNDER SECTION 17 OF THE CROWN LANDS ORDINANCE THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR AND THE LEGISLATIVE COUNCIL:—

1. These Regulations may be cited as the Crown Lands (Amendment) Regulations, 1954, and shall be construed and read as one with the Crown Lands Regulations, 1919, hereinafter referred to as the Principal Regulations, and any Regulations amending the same.

2. Regulation 2 of the Principal Regulations is hereby amended by the addition thereto of the following sub-regulation —

"(5) Sub-regulation (4) of this regulation shall not apply to applications for woodcutting leases or woodcutting licences. In the case of any such application when a survey of the tract is required the survey fee shall be deposited at the time of the application."

3. Regulation 48 of the Principal Regulations is hereby amended by the substitution for the words "twelve months" of

the words "two years".

4. Regulation 50 of the Principal Regulations is hereby

revoked and the following substituted therefor —

"Rent. 50. The rent payable on a licence or lease shall be at the rate of one cent for each period in respect of which the licence or lease has been granted or renewed as the case may be."

5. The First Schedule to the Principal Regulations as

amended from time to time, is hereby further amended —

(a) (i) by the insertion therein in item 1 after the word "Lease" of the words and brackets "(other than a woodcutting lease)";

(ii) by the deletion of the words and commas ", Wood-

cutting Licence," in item 1;
