THE PUBLIC CORPORATIONS ACT 1988

(No. 21 of 1988)

WHEREAS the Sanata Textiles Limited (hereinafter referred to as "the Company") is a company incorporated in Guyana under the Companies Act and wholly owned by the State:

AND WHEREAS sections 5, 8.9 and 11 of the Public Corporations Act. 1988 (hereinafter referred to as "the Act") was applied to the Company with the required modifications by notification under sections 66 of the Act:

NOW THEREFORE, IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 5,8,9 AND 11 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO THE SANATA TEXTILES LIMITED, BY NOTIFICATION UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER:

Citation and commencement

1. This Order may be cited as the Sanata Textiles Limited (Dissolution and Transfer of Assets and Liabilities) Order 2000 and shall come into operation on the appointed date.

Interpretation

- 2. In this Order: -
 - (a) "appointed date" means the 29th December, 2000

(b) "Company" means the Sanata Textiles Limited, being a company incorporated in Guyana under the Companies Act and continued under the Companies Act 1991, with registered office at Industrial Site Ruimveldt, Georgetown, Demerara.

Cap 89:01 No 29 of 1991 (c) NICIL" means National Industrial and Commercial Investments Limited, being a company incorporated in Guyana under the Companies Act and continued under the Companies Act 1991, with registered office at 126 Barrack Street, Kingston, Georgetown, Demerara.

Dissolution of Company

3. The Company shall stand dissolved from the appointed date.

THE RESIDENCE IN COMMENTS.

Transfer of Assetand Liabilities

- 4(1) All the assets of the Company whether movable or immovable. (including rights, claims and interest) vested in the Company immediately before the appointed date shall, as from the appointed date and without further assurance, stand transferred to and vested in the NICIL.
 - (2) The assets transferred to and vested in NICIL under paragraph (1) shall include: -
 - (i) the immovable property described in Schedule I.
 - (ii) the movable property described in Schedule II.
 - Subject to the provision of paragraph (4), all the liabilities including:
 - severance pay benefits payable to persons whose (i) employment with the Company is terminated under clause 5: and
 - the liabilities of the Company to the National Bank of (ii) Industries and Commerce secured under a debenture dated the 30th August 1991.

incurred by the Company prior to, and subsisting immediately before the appointed date shall, as from that date, be transferred to and vested in NICIL. and shall be discharged by, and be enforceable against. NICIL as if the said liabilities had been incurred by NICIL.

(4) Any liabilities the Company may have with the Government of the Peoples Republic of China, subsisting immediately before the appointed date shall, as from the appointed date, stand transferred to and vested in the Ciovernment.

Fermination of employment of employees

The employment of all the employees by the Company is hereby terminated as from the appointed day.

Enforceability of deeds, etc. and legal proceedings

All deeds, bonds, instruments, contracts or other documents which were subsisting immediately before the appointed day, and relating to any assets or habilities of the Company hereby transferred to NCIL, shall be of full force and effect against, or in favour of NICIL and be enforceable as fully and effectively as if, instead of the Company, NICII, had been named therein or had been a party thereto
