AN ACT to amend the Tax Act.

A. D. 1992 Enacted by the Parliament of Guyana:

Short title. Cap. 80:01 1. This Act, which amends the Tax Act, may be cited as the Tax (Amendment) (No. 2) Act 1992.

Amendment of section 34 of the Principal Act. 2. Section 34 of the Principal Act is hereby amended by the substitution for the words "three thousand dollars" of the words "five thousand dollars".
