This Bill seeks to amend the provisions relating to fines imposed on persons convicted under the Cattle Stealing Prevention Act, Cap. 9:03. There is no gainsaying the fact that the existing fines are insufficient because of hyperinflation which has plagued the economy coupled with the falling value of the Guyanese currency. The primary object of the Bill is, therefore, to increase the fines so as to remedy the situation.
