Short title.

I. This Act, which amends the National Insurance and Social Security Act, may be cited as the National Insurance and Social Security (Amendment) Act 1997.

Amendment of Section 2 of the Principal Act. Section 2 of the Principal Act is hereby amended by the deletion of the definitions of "contribution card" and "insurance stamp".

Amendment of section 17 of the Principal Act. 3. Section 17 of the Principal Act is hereby amended in the following respects —

(a) by the deletion of subsection (2);

(b) in subsection (3), by the

substitution for the words "insurance

stamps" of the words "cash or cheque"

wherever they occur.

4. Section 19 (1) (a) of the Principal

Act is hereby amended in the following respects —

(a) in subparagraph (v), by the substitution for the words "periodical payments" of the words "a payment or periodical payments";

(b) in subparagraph (vii), by the substitution for the full stop at the end of a semicolon and by the insertion immediately thereafter of the following subparagraph -

"(viii) constant attendance benefit, that is to say, a payment or periodical payments to an invalid or disabled person who is in receipt of a pension under this Act.".

EXPLANATORY MEMORANDUM

This bill seeks to amend the National Insurance and Social Security Act, Cap. 36:01, to remove references to a card and stamp system and to make provision for the payment of an additional benefit to an invalid or disabled person who receives a pension under this Act. It also seeks to increase the penalties to more realistic levels bearing in mind the decline in value of the Guyana dollar.
