PREVENTION OF CRIMES (AMENDMENT) BILL 1998

ARRANGEMENT OF SECTIONS

### SECTION

- 1. Short title.
- 2. Amendment of the Principal Act.

#### A. BILL

#### Intituled

AN ACT to amend the Prevention of Crimes Act.

A.D. 11998

Enacted by the Parliament of Guyana:-

Short title. Cap. 9:01 1. This Act, which amends the Prevention of Crimes Act, may be cited as the Prevention of Crimes (Amendment Act 1998.

Amendment of the Principal: Act. 2. The sections of the Principal Act mentioned in the first column of the Schedule are hereby amended in the manner specified in the corresponding entry in the second column of the Schedule.

Section 7	For "seven thousand five hundred dollars" substitute "fifteen thousand dollars", for "fifteen thousand dollars" substitute "thirty thousand dollars", for "one month" substitute "two months" and for "three months", substitute "six months".
Section 8	In paragraph (b), for "fifteen thousand dollars" substitute "thirty thousand dollars".
Section 9	In subsection (2), for seven thousand five hundred dollars" substitute "not less than seven thousand five hundred dollars nor more than fifteen thousand dollars" and for "ten thousand dollars" substitute "not less than ten thousand dollars nor more than twenty thousand dollars".
Section 12 (a)	In subsection (1) (a), for "twenty thousand dollars" substitute "not less than twenty thousand dollars nor more than forty thousand dollars" and for "six months" substitute "twelve months."
Section 9	In paragraph (b), for "fifteen thousand dollars" substitute "thirty thousand dollars".  In subsection (2), for seven thousand five hundred dollars" substitute "not less than seven thousand five hundred dollars nor more than fifteen thousand dollars" and for "ten thousand dollars" substitute "not less than ten thousand dollars nor more than twenty thousand dollars". (b) In subsection (1) (b), for "two years" substitute "four years".

Section 15

In subsection (4), for "fifteen thousand dollars" substitute "not less than fifteen thousand dollars" nor more than "thirty thousand dollars" and for "three months" substitute "six months".

Section 16

In subsection (2), for "fifteen thousand dollars" substitute "thirty thousand dollars", for "forty thousand dollars" substitute "eighty thousand dollars", for "three months" substitute six months" and for "six months" substitute "twelve months".

Section 18

For "thirty thousand dollars" substitute "not less than thirty thousand dollars" nor more than sixty thousand dollars" and for "four months" substitute eight months".
