AN ACT to amend the Cattle Stealing Prevention Act.

Enacted by the Parliament of Guyana:-

Short title. Cap. 9:03

1. This Act, which amends the Cattle Stealing Prevention Act, may be cited as the Cattle Stealing Prevention (Amendment) Act 1998.

Amendment of the Principal Act. 2. The sections of the Principal Act mentioned in the first column of the Schedule are hereby amended in the manner specified in the corresponding entry in the second column of the Schedule.

Section 5	For "five hundred dollars" substitute not less than five hundred dollars nor more than one thousand dollars".

Section 8	For the words beginning with the words "and everyone" and ending with the word "dollars" substitute "not less than seven thousand five hundred dollars nor .more than fifteen thousand dollars".
Section 9	In subsection (3), for "fifteen thousand dollars" substitute "not less than fifteen thousand dollars nor more than thirty thousand dollars" and for twelve months" substitute "two years".
Section 11	In subsection (1), for "twenty thousand dollars' substitute "not less than twenty thousand dollars nor more than forty thousand dollars" and for "twelve months" substitute "two years".

Section 25	In subsection (2), for "not exceeding twenty-five thousand dollars" substitute "exceeding twenty-five thousand dollars but not exceeding fifty thousand dollars" and for "not exceeding two years" substitute "exceeding two years but not exceeding four years".

EXPLANATORY MEMORANDUM

The Act which this Bill amends was amended in 1997 to increase penalties. It is now being further amended to provide for a minimum benchmark for each offence and to increase custodial sentences.
