- 1. This Act, which amends the Exchange Control Act, short title may be cited as the Exchange Control (Amendment) Act 1990 and commend and shall be deemed to have come into operation on 1st Nov-Cap. 86:01 ember, 1989.
- 2. Section 4 of the Principal Act is hereby amended by Amendment the insertion, after subsection (6), of the following subsection as of the Principal Act.
 - "(7) For the purposes of this section any specified currency utilised for settling, in that currency, any monetary obligation or transaction authorised or required by law, or by agreement entered into in accordance with section 21 (1) of the Bank of Guyana Act, to be settled in that specified currency shall be deemed to have been sold to an authorised dealer."

EXPLANATORY MEMORANDUM

This Bill seeks to amend section 4 of the Exchange Control Act, Cap. 86:01, to provide that any foreign currency utilised to settle, in that currency, monetary obligations and transactions authorised or required by law, or by agreement entered into in accordance with section 21 (1) of the Bank of Guyana. Act, Cap. 85:02, to be settled in that foreign currency, shall be deemed to have been sold to an authorised dealer.
