# EVANGELICAL LUTHERAN CHURCH (INCORPORATION) (AMENDMENT) BILL 1975

A Bill intituled:

"An Act to amend the Evangelical Lutheran Church (Incorporation)
Ordinance. [Mr. Sukul)

**Mr. Sukul**: Your Honour, on the 11<sup>th</sup> October,1975, I presented to the Assembly a Petition from the Executive Committee of the Evangelical Lutheran Church seeking to have introduces inn the Assembly a Private Bill to amend the Ordinance which incorporated the Church. The Assembly granted leave for the Promoters to proceed. The amended Bill was published in the Gazette and in the Daily Chronicle Newspaper on the 11<sup>th</sup>, 18<sup>th</sup> and 25<sup>th</sup> January,1975, and was introduced in the Assembly on the 29<sup>th</sup> January.1975.

By an Ordinance enacted in 1948, the Church was incorporated in Guyana as the Evangelical Lutheran Church. A few years ago it was decided at the convention of the Church that the name of Church should be changed from "the Evangelical Lutheran Church" to the "Lutheran Church."

The object of the Bill before the Assembly is to give effect to the change, that is, to amend the Ordinance to omit the word "Evangelical" wherever it appears in the Ordinance. The Bill, therefore, is very simple one and I commend it to the Assembly and now move that it be read a Second time.

#### **BILL - SECOND READING**

#### PENSIONS (AMENDMENT) BILL 1975

A Bill intituled:

"An act to amend the Pensions Act."

Mr. Speaker: Hon. Minister of Finance.

The Minister of Finance (Mr. Hope): Mr. Speaker I rise to move the Second Reading of the Pensions (Amendment) Bill. In accordance with the Article 80 (2) of the Constitution I signify that the Cabinet has recommended that the Pensions (Amendment) Bill be considered by the National Assembly.

The Pensions Act already provides for service in certain agencies to be counted as service for the purpose of pensions for public servants under the Pensions Act. At the

moment the Municipal District Council's Act already provided for the case where a public officer in a pensionable post is seconded to a to a Municipality or a District Council to be counted as service for pensionable purpose. In other words, where a public officer leave a pensionable employment on secondment on a temporary basis to a Municipality or a District Council that the officer is guaranteed that his pensionable service with the Government is not broken and that the period he a spends on secondment on a temporary basis with the District Council or Municipality, is, in fact, counted as part of his pensionable services.

What this Bill seeks to do is to take account of those long service employees who might have been with the Government but who also had service with the Municipality. Unless we proceed to approve this Bill it would mean that such long - service employees would, in fact, have a very short service for pension purpose under the Pensions Act on the basis of which they would have retired. Taking account of the fact that already it is recognised that officers moving from the public service into the Local Government service can have their pensionable service maintained, We think it is only right and proper that long – service employees, that is, people with long service straddling both Local Authority and the Central Government service should retire on the basis that their service in the Municipality or District Council, in other words, any Local Government agency is, in fact, counted as part of their pensionable service.

For this reason we have brought this Bill in order to ensure that these employees do not suffer by the mere fact that the exigencies of the service to the country required them to leave a Local Authority and work with the Central Government. In effect, we have covered the long – service employees by putting the commencement date for the counting of the service as January 1948 and, of course, it will affect all persons who retire after the 31<sup>st</sup> January, 1975.

We have also sought in the Bill to give the Minister power, by Order, to extend this special list under Section 23 of the Pensions Act. Under that Section, we have such service as the Society for Prevention And Treatment of Tuberculosis; service in the Infant

Welfare and Maternity League and service in the New Amsterdam Fire Service prior to the 1<sup>st</sup> January, 1953. We are going to have, if this Bill is passed, service to the Local Authority within a certain period. The Bill goes on to seek specifically to give the Minister the power to make an Order to extend this list in given circumstances when those circumstances make it appropriate for this to be done.

That, sir, is the simple function of this Bill and I therefore, formally at this stage, move the Second Reading in the hope that it will win unanimous support from the House.

DRAINAGE AND IRRIGATION /(AMENDMENT) BILL

A Bill intituled.

"An Act to amend the Drainage and Irrigation Act."

Mr. Speaker: Hon. Minister of Agriculture.

The Minister of Agriculture (Mr. Kennard): Your Honour, I beg to move that the

Drainage and Irrigation (Amendment) Bill, 1975, be now read a second time. The Bill is a very

simple one and amends the principal Act, namely the Drainage and Irrigation Act, Chapter

64:03. The need to amend the Act arises from the change in the holder of the post under which

drainage and irrigation fall.

Section 4(1) of the Drainage and Irrigation Act provided for the holder of the post of

Chief Works and Hydraulic Officer to be a member of the Drainage and Irrigation Board but the

Hydraulic Division has now been integrated with the Ministry of Agriculture and it is therefore

necessary for the Chief Hydraulic Officer to be a member of the Board in his place. This Bill,

therefore, seeks to provide legislation for that purpose.

In addition, the Bill seeks to provide for certain consequential amendments relative to the change in the particular holder of the post and it provides for places where documents and plans and estimate pertinent to Drainage and Irrigation projects shall be deposited. There are, therefore, amendments to Section 15(1)(a), 15(1)(b) and 15(1)(c).

Question Proposed.

**Mr. Speaker**: Hon. Leader of the Opposition.

The Leader of the Opposition (Mr. Singh): Mr. Speaker, I do agree with the Hon. Minister that the Bill is indeed a very simple one and of course, we would not complicate it by going into any long discussion and irrigation, particularly at a time when my throat is not feeling too well. It is a necessary procedural matter, as the hon. Minister said, consequent on the transfer of the Hydraulics Division to the Ministry of Agriculture from the Ministry of Works.

We agree that the Hydraulic Division should properly belong to the Ministry of Agriculture and so we heartily support the Bill which, as we said, is merely a procedural matter.

#### **MOTION**

#### GUARANTEE OF LOAN TO BERBICE MINING ENTERPRISE LINITED

"Be it resolved that this National Assembly do hereby Authorise the Minister of Finance to give the guarantee in the sum of \$16,500,000 (sixteen million five hundred thousand Guyana Dollars), in accordance with the State Enterprises (Guarantee) Act 1974. [The Minister of Finance]

**Mr. Hope**: Your Honour. I beg to move the Guarantee of Loans to the Berbice Mining Enterprise Limited Motion. It is well known to this House, as to the country and indeed, to the world at large, that this Government acquired the assets of the Reynolds Metals Company to Guyana on the first day of this year. As was our experience in the past, when the enterprise was taken over, there was no working capital available in the accounts of the nationalised company In fact, as is well known, this particular company operated its business in Guyana in the full tradition of an absentee landlord: in this case, an absentee shareholder.

In the circumstances, very little of the financial transactions pertaining to this particular enterprise, that is, the Reynolds Metals Company in Guyana was in fact conducted in Guyana. The enterprise, as is well known, was the mere extension of the Reynolds Enterprises operating out of Richmond, Virginia, in the United States of Americas. It was therefore necessary for a substantial amount of re – organisation to be done to the enterprise that was taken over so as to ensure that what we have is a viable enterprise in the immediate months ahead. We know that it is well within the capacity of the people of Guyana, having assumed the ownership of these particular assets, to operate those assets as a going concern and profitable concern. But, to do that, certain necessary impute must be made into the company, in particular, inputs to ensure that the equipment that have been taken over are modernised and the necessary working capital is provide

It has been estimated that to do this, it would require an infection of an amount of something like \$16 ½ million (G), immediately, so as to ensure that funds are available for bringing the assets into the best and maximum working conditions in terms of their efficiency and to ensure that there is adequate working capital to run a smooth business.

To do this, it was necessary to negotiate loans with lending agencies operating in Guyana and the people who are in charge of the company have been able to do this. One of the conditions

involved is quite naturally, the provision of a Government guarantee to cover the advance of \$16.5 million. It is therefore in that context that the Motion is brought to this House in order to secure approval for the government to guarantee a sum of \$16,000,000 which the State Enterprises (Guarantee) Act 1974. I, therefore, formally move the Motion for its adoption.

Question Proposed

**Mr. Singh:** Mr. Speaker, the Opposition heartily supports this Motion. It is indeed a necessary supplement to the nationalization of Reynolds (Guyana) Mines Ltd. The Opposition to totally committed to do everything within its power to ensure the success, we are committed to the success of Guybau, for if any were to fall, all Guyana will suffer.

May I also take this opportunity to say that the Opposition is very happy to announce that in the spirit of consultation between the Government and the Opposition, the Opposition was requested to, and we did, nominate for appointment, one of the present directors of this now Company, Berbice Mining Enterprise Ltd. We wish this new company every success from the bottom of our hearts.

Question put and agreed to.
