Consideration of the Draft Estimates (Recurrent and Development) for 1959.

Mr. C.M. Fraser, Commissioner of Housing (Acting), was present during consideration of HEAD 6 - CENTRAL HOUSING AND PLANNING AUTHORITY and HEAD IX - HOUSING (DEVELOPMENT).

HEAD 6 - CENTRAL HOUSING AND PLANNING AUTHORITY passed as printed \$48,113:-

HEAD IX - HOUSING (DEVELOPMENT)

Following a discussion initiated by Mr. Campbell on the abovenamed Head, the Committee recommended that the Government should examine the question of the leases granted to residents in the North West District with a view to determining whether it would be possible for the residents concerned to obtain transport of the lands on which their houses have been constructed.

Subhead 36 - Grant towards running expenses of Georgetown Mariners Club\$5,000:-

Following a discussion on the above subheads (consideration of the latter having been deferred at the previous day's meeting), the Committee recommended that subhead 35 be increased by \$1,900:-

- Subhead 36 Grant towards running expenses of Georgetown Mariners Club, was accordingly decreased by \$1,900:- and passed at \$3,100:-
