### PRAYERS

The Honourable Dr. C.B. Jagan, Minister of Trade and Industry, on behalf of the Members of the Council thanked His Excellency for his Address and asked that it be printed and circulated to Members.

Thereafter His Excellency withdrew from the Chamber.
