INTRODUCTION OF BILLS - First Reading.

BILLS - Second and Third Readings.

item 1 - NATIONAL DEVELOPMENT SAVINGS LEVY BILL, 1962 Bill No. 16/1962 (L.A.) (Money Bill).

The relevant Standing Orders were suspended to enable the Senate to proceed with the remaining stages of the BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE LEVY OF COMPULSORY SAVINGS TO BE UTILISED FOR WORKS OF DEVELOPMENT IN BRITISH GUIANA, AND FOR THE ISSUE OF BONDS THEREFOR, THE PAYMENT OF INTEREST THEREON AND OF PRIZES WITH RESPECT THERETO AND FOR THE REDEMPTION THEREOF.

On a motion by the Minister of Trade and Industry, the Bill was read a second time. There after, the Bill was read the third time and passed as printed.

Item 2 - TRANSPORT AND HARBOURS (AMENDMENT) BILL, 1962 - Bill No. 17/1962 (L.A.)

The relevant Standing Orders were suspended to enable the Senate to proceed with the remaining stages of the BILL intituled AN ORDINANCE TO AMEND THE TRANSPORT AND HARBOURS ORDINANCE.

On a motion by the Minister of Trade and Industry, the Bill was read a second time and was thereafter taken through its remaining stages and passed as printed.
