BROADCASTING BILL 2011 – Bill No. 13/2011 published on 2011-07-15

The Prime Minister and Minister of Public Works and Communications moved the second reading of the following Bill:

A BILL intituled AN ACT to make provision for the establishment of the Guyana National Broadcasting Authority responsible for the regulation, supervision and development of the National Broadcasting System, to provide for its functions, and to provide for the licensing of broadcasting agencies and the encouragement of production and broadcasting of television and radio programmes having relevance generally to life and culture of the people and for consequential and related matters.

The Bill was then read a second time.

The Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

Clauses 1 to 18 were passed as printed.

Clause 19

The Prime Minister and Minister of Public Works and Communications moved the following amendments which were <u>put</u> and <u>carried</u>:

"Clause 19(b) -

Delete the word 'that' at the beginning of the sentence.

Clause 19(j)

Before the words 'be varied' in the first line, insert the word 'it'

Clause 19(p) –

Before the words 'be responsive' in the first line, insert the word 'it'

Clause 19(q) –

For the words 'that broadcasting shall ensure' in the first line, substitute the word 'ensures'"

Clause 19 was then <u>passed</u> as <u>amended</u>.

Clauses 20 to 22 were passed as printed.

Clause 23

The Prime Minister and Minister of Public Works and Communications moved the following amendments which were <u>put</u> and <u>carried</u>:

"Clause 23(1)(b)(ii) –

After the word 'nationals' in the fourth line, insert the words 'except as provided for in section 19(a)(ii)'

Clause 23(1)(b)(iv)(b) -

For the words 'sale, change in directors or transfer of controlling shares' in lines 5 and 6, substitute the words 'same licence'"

Clause 23 was then passed as amended.

Clauses 24 to 32 were passed as printed.

Clause 33

The Prime Minister and Minister of Public Works and Communications moved the following amendment which was <u>put</u> and <u>carried</u>:

"Clause 33(2)(e) –

Delete the words 'and (d)' in the fourth line".

Clause 33 was then <u>passed</u> as <u>amended</u>.

Clauses 34 to 39 were passed as printed.

Clause 40

The Prime Minister and Minister of Public Works and Communications moved the following amendment which was <u>put</u> and <u>carried</u>:

"Clause 40(2) –

After the word 'Authority' in line 2, delete the words 'in two equal installments payable on or before 30th June, 2012 and on or before 31st December, 2012'"

Clause 40 was then passed as amended.

Clauses 41 to 48 were passed as printed.

Assembly resumed

On the motion by the Prime Minister and Minister of Public Works and Communications, the Broadcasting Bill 2011 was read a third time and <u>passed</u> as <u>amended</u>.
