COMMENCEMENT OF SITTING

The Sitting commenced at 2.20 p.m.

PRAYERS

The Clerk read the prayers.

Resignation of Mrs. Deborah J. Backer, M.P., Deputy Speaker of the National Assembly

The Speaker informed Members that he had received from Mrs. Deborah J. Backer, M.P., Deputy Speaker of the National Assembly, a letter dated 31st January, 2014, resigning her seat as a Member of Parliament, with effect from 7th February, 2014.

With Mrs. Backer's resignation, a seat in the National Assembly became vacant.

The vacancy was, in accordance with Section 99A of the Representation of the People's Act, Chapter 1:03, to be filled by a person whose name was to be extracted from the list of candidates from which Mrs. Backer's name was extracted.

As Mrs. Backer's name was extracted from A Partnership For National Unity List of Candidates, the Speaker had, in accordance with Section 99A of the said Act, called upon the Representative of the said list to further extract from that list the name of a person who was willing to become a Member of the National Assembly, to fill the vacancy in the Assembly.

OATH OF A NEW MEMBER

Dr. Karen Cummings, M.P.

The Speaker, informed Members that following the resignation of Mrs. Deborah Back and his call upon the Representative of A Partnership For National Unity List of Candidates, he had been informed that the name of Dr. Karen Cummings was extracted from the list and that Dr. Cummings was on the 10th February, 2014, declared to be an elected Member of the National Assembly.

The Speaker stated that before Dr. Cummings could take part in the proceedings of the Assembly, she would have to make and subscribe the oath before the Assembly as required by Article 167 of the Constitution.

As Dr. Cummings was present, she made and subscribed the oath which was administered to her by the Clerk.

Ms Amna Ally, M.P., Opposition Chief Whip, seconded by Dr. Rupert Roopnarine, M.P., nominated Mr. Basil Williams, M.P. There being no further nomination, the Speaker declared Mr. Basil Williams, M.P., as the duly elected Member to be the Deputy Speaker of the National Assembly.

ITEM 4 - APPOINTMENT OF MEMBERS OF THE ETHNIC RELATIONS COMMISSION

Dr. George Norton, M.P. (Chairman of the Committee on Appointments), moved the following motion:

WHEREAS Article 212A of the Constitution provides for the establishment of an Ethnic Relations Commission;

AND WHEREAS in accordance with Article 212 B (1) of the Constitution, the Ethnic Relations Commission shall consist of –

- (a) "not less than five nor more than fifteen members, nominated by entities, by a consensual mechanism determined by the National Assembly, including entities, representative of religious bodies, the labour movement, the private business sector, youth and women, after the entities are determined by the votes not less than two-thirds of all elected members of the National Assembly;
- (b) a member who shall be a nominee, without the right to vote, chosen by and from each of the following commissions to be established under this Constitution, Indigenous Peoples' Commission, Women and Gender Equality Commission, Commission for the Rights of the Child and Human Rights Commission."

AND WHEREAS the Parliamentary Standing Committee on Appointments (COA) examined the list of entities to nominate members to the Ethnic Relations Commission in accordance with article 212 B (1)(a) of the Constitution, and Resolution No. 62 of 2000 with regard to the number of members on the said Commission;

AND WHEREAS the Parliamentary Committee on Appointments recommends that the number of members on the Ethnic Relations Commission be increased to ten (10) and the categories or groups include the representatives of the Christian, Hindu, and Muslim bodies, the labour movement, the private business sector, youth and women and a new category "Cultural/Ethnic" with one nominee each from the three (3) largest ethnic groups: Indo-Guyanese, Afro-Guyanese and Indigenous/Amerindian.

BE IT RESOLVED:

That this National Assembly approves the increase in the number of members on the Ethnic Relations Commission from seven (7) to ten (10) as proposed by the Committee on Appointments;

BE IT FURTHER RESOLVED:

That this National Assembly approves of the inclusion of a new category "Cultural/Ethnic" with the right to have three (3) members, one representative each of the three largest ethnic groups;

BE IT FURTHER RESOLVED:

That this National Assembly approves the list of entities on the attached First Schedule in accordance with Article 212 (B)(1)(a);

BE IT FURTHER RESOLVED:

That this National Assembly approves that the number of nominees for each group of entities be as follows:-
