whether the public supplier can supply electricity at no more than the cost that would be incurred by the applicant if he were to generate the electricity himself; and, if granted by the Minister, such licence shall be valid for the term of the normal life of the equipment to be utilized by the applicant for the generation of electricity, up to a maximum of twenty-five years, and shall restrict the applicant to selling, giving or distributing electricity to himself, his relatives, his employees and officials, schools, athletic clubs, canteens and non-profit organizations in the vicinity of the source of his generation capacity:"
