THE TRADE ORDINANCE, 1958 (No. 34 of 1958).

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:—

- 1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969* may be cited an the Trade (Control of Prices) (Amendment) (No. 6) Order, 1971.
- 2 (1) Clause 5 of the Principal Order is hereby revoked and the following clause substituted therefor—
 - "5. For the purposes of this Order "duty paid price" means the aggregate of the value of the respective goods determined for the purpose of assessing any duties of customs or consumption tax or Bill of Entry tax payable thereon and any such duties and taxes (including any sum paid in the nature of a commission to the Government)."
- (2) The amendment effected by paragraph (1) shall be deemed to have come into operation on the 15th February, 1971.
- 3. Part A of the First Schedule to the Principal Order is hereby amended in the following respects
 - (a) by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, against the articles of foodstuff numbered 23, (Onions) and 29, (Cheese) of the particulars appearing against those numbers in the third, fourth and fifth columns, respectively of Part A of the schedule to this Order; and
 - (b) by the addition in the respective columns of the articles of foodstuff numbered 46, (Herrings) and

47, (Peanut Butter) together with the particulars thereof appearing in Part A of the Schedule to this Order.

- 4. Part B of the First Schedule to the Principal Order is hereby amended in the following respects—
 - (a) by the substitution for the particulars appearing inthe third, fourth and fifth columns, respectively, against the articles of foodstuff numbered 23, (Onions) and 29, (Cheese) of the particulars appearing against those number in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order; and
 - (b) by the addition in the respective columns of the articles of foodstuff numbered 46, (Herrings) and 47, (Peanut Butter) together with the particulars thereof appearing in Part B of the Schedule to this Order.
