IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 8 AND 11 OF THE PUBLIC CORPORATIONS ACT 1988 I HEREBY MAKE THE FOLLOWING ORDER:-

Citation and commencement. 1.

This Order may be cited as the Guyana Airways
 Corporation (Transfer of Assets) Order 1999 and
 shall come into operation on 16th April, 1999.

Interpretation.

- 2. In this Order -
- (a) "appointed day" means the date on which this Order comes into operation;

(b) "Corporation" means Guyana Airways
Corporation, a public corporation under
the Public Corporations Act 1988, having
its registered office at 32 Main Street,
South Cummingsburg, Georgetown,
Demerara;

No. 29 of 1991

(c) "Guyana Airways 2000" means Guyana Airways 2000 Inc., a company incorporated under the Companies Act 1991, having its registered office at 32 Main Street, South Cummingsburg, Georgetown, Demerara.

Transfer of assets of the Corporation.

- (1) The right, title and interest (whether registered or not) of the Corporation in and to the following assets are from the appointed day transferred from the Corporation to Guyana Airways 2000 -
 - (a) the immovable property vested in the Corporation and described in Part I of the Schedule;
 - (b) the property and the buildings, erections and structures described in Part

Schedule

II of the Schedule;

- (c) the motor vehicles described in Part III of the Schedule;
- (d) the aircraft listed in Part IV of the Schedule and the associated spares and spare parts;
- (e) all other property of the Corporation including office equipment and supplies, furniture and fittings, machinery, equipment, tools and other assets used in and for the purposes of its operations or in connection with the transferred assets but excluding cash in hand, in transit or at the bank, book debts and accounts receivable, deposits, prepayments, cheques and securities representing the same, insurance or other claims, spares and spare parts other than those referred to in paragraph (d) and shares and other investments.
